# ALUMNI NEWS BULLETIN WISCONSIN STATE COLLEGE

Stevens Point, Wisconsin

#### Greetings to Alumni:

We welcome this opportunity to extend greetings to you on behalf of our Alma Mater. We hope your work is going well for you.

Here at the college we are busy with plans for expanding our facilities. We have long since outgrown our present quarters. Wisconsin has a real problem ahead in higher education. No matter how rapidly the state proceeds to build college buildings at the state colleges and the university it cannot keep up with the rapid enrollment increase which will be at the college doors in 1963 to 1970. We might conceivably catch up in ten years, but it isn't likely before then. You can help the situation by impressing this idea upon any member of the Legislature whom you may know. I doubt if the Legislature is fully aware of the problem ahead of it.

This spring we will remodel the space vacated in the old gym in the main building. This will give us about a half dozen classrooms and some offices in addition to what we now have. That will help for a year.

We are also starting two new dormitories for men this spring. They will be across the street (N. Reserve) from the new physical education building. They are to be ready for occupancy in September 1962 and will accommodate 400 men. We can then use Delzell and Steiner Halls for women.

We also have high priority on a new science building. It is in the planning stage and should be under construction early next spring (1962). It will house the chemistry, biology and physics departments and should be ready to occupy in September 1963. That building will release a good deal of space in the old main building, as you can readily visualize, and that will alleviate pressure for space for two or three years. Our plan is to locate the new science building directly across Fourth Avenue from the new physical education building, hoping eventually to tie the new north campus to the old campus. It will require the purchase of quite a bit of residential property during the next ten years. So some day when you come back for a visit you may find the college campus about a mile and a half in length, all connected and pretty well covered with buildings.

# Important Reminder To Education and L. & S. Alumni

All CSC Alumni are reminded of the importance of keeping their credentials up to date and ready for placement purposes on short notices. Many graduates have already recognized the importance of this procedure to them and have been able to obtain excellent promotions because these materials were up to date and available when needed. There are, however, far too many who seem to have forgotten the importance of the procedure. Some make application for a new position which results in a request being sent by the school administration for up to date credentials on short notice. Alumni who anticipate the need for credentials to be used for placement purposes should plan well in advance to have them brought up to date with all experience completed and additional preparation which should be added to the credentials. A letter addressed to the Placement Office requesting the forms necessary for this purpose will initiate the necessary procedures to assure quick and effective placement service, when the credentials have been brought up to date.

The placement office is receiving many requests for credentials of candidates who had completed graduate preparation. We are sure there are a number of graduates from this college who have completed such graduate work but who have not reported it so that it could be included in their credentials. This means that when requests come to this office placement officials are unable to include those recommendations in those submitted to employing officials.

May we urge that you keep this important matter in mind and see that your credentials are always up to date and available for placement purposes.

#### Amacher and Briscoe To Attend International Meet

Mr. John Amacher, director, and Keith Briscoe, assistant director, College Union, Central State College, will attend the 38th annual Association of College Unions international conference at Colorado Springs, Colo. The conference will be held April 16–19.

# Retired Campus School Supervisor Dies



Following an extended illness, Mrs. Edith Cutnaw, former supervisor in the Campus Laboratory School, died at her daughter's home in Menomonie last October. Mrs. Cutnaw joined the college staff in 1939, serving as supervisor of student teaching in the junior high school. Her education began in the public schools of Winneconne, then the Oshkosh Normal School and received her Bachelor of Philosophy Degree at Ripon College. Through summer school at the University of Chicago and the University at Madison are received her Masters Degree in 1954.

Her experience included teaching at the rural schools, county Normal, Iowa State Teachers College, Dickinson, North Dakota State Teachers College before joining the staff at Stevens Point. She was born in Winneconne, was a member of the Presbyterian Church, the Eastern Star, AAUW, Phi Delta Gamma, Sigma Tau Delta, Phi Gamma Phi, Pi Lambda Theta, The Business and Professional Women's Club and Stevens Point Women's Club. Her husband died in 1938, leaving her with a son Kent who was killed in the Second World War and a daughter Mary Francis, currently Professor of Speech at Stout State College.

In addition to her interest in Teacher Education she had an unusual interest in Remedial and Corrective Reading. Among articles published were, "Why So Many Poor Readers," published in the Wisconsin Journal of Education. She was founder and Director of the Junior Theater of the Campus Laboratory School. Many students were provided the opportunity to appear publicly in a theatrical production through this activity. A scholarship fund has been established for Mrs. Cutnaw for those interested in having a part in continuing the programs she helped to initiate. It is the "Edith and Kent P. Cutnaw Scholarship Fund", ro reward upperclassmen interested in teaching Social Studies or in entering law.

# C.S.C. Grad Given Honorable Mention

Mr. Jerry Madison has been given honorable mention by the Woodrow Wilson National Fellowship Foundation. He was among those selected for this honor from 10,453 nominees. Past experience from the foundation indicates that most honorable mention winners will receive alternate awards either directly from universities and colleges or other organizations. The Woodrow Wilson Foundation is constantly searching for outstanding college students and college graduates who are interested in college teaching as a career. Dr. Eagon is the college representative for the Woodrow Wilson Foundation and would be interested in hearing from any student with an outstanding college record who has not had more than one year of graduate work and is interested in making application for this fellowship grant.

# Cooperative Master's Graduate Program

This program is designed for experienced elementary and secondary teachers. For qualified candidates, the program will lead to the Master of Science Degree in a teaching field after four 8-week summer sessions, two at a state college, and two at institutions participating in the Cooperative Master's Degree Program --- University of Wisconsin, Madison and Milwaukee, Stout State College, and Superior State College.

Admission requirements are: 1. A bachelor's degree from an accredited institution. 2. Certification to teach in Wisconsin. 3. One year of teaching experience, except for the first summer session following graduation. 4. An undergraduate overall gradepoint average of 2.75 (4.00 basis; C is 2.00). 5. Good mental and physical health.

Applicants should write to Dr. Burdette W. Eagon, Director of Graduate Study at Stevens Point, requesting an application form. Graduate summer session will be from June 12 to August 4. The cost for the full six credit program will be \$74. Books for the courses will be purchased by the student.

#### From Dean Gordon Haferbecker

Stevens Point like the other state colleges will again have an eight week summer session in 1961. The graduate program which began in 1960 with eight credits offered will expand so that 17 courses will be available. We expect about 80 master's degree students this summer. The college will offer six credits in Safety Education and Driver Education which will enable students to meet state requirements for certification as teachers of driver education. If there is sufficient demand, three courses in library science will be available for those working for teacher-librarian certification.

The Summer Music Camp for high school students has been such a success that a junior high school camp has been added to the 1961 summer program. High school students will attend from June 11 to June 25 and junior high school students from July 9 to July 16. Included in the program will be two major performance groups: chorus and band. In addition to daily rehearsals for these groups, other course offerings will include: music theory, conducting, music appreciation, small ensembles, piano workshop, and private instruction in applied music. Supervised recreation will be provided. Students will be housed and fed in the college dormitories.

The college and the Wisconsin Conservation Department are sponsoring a five week, work-study field project, June 12 to July 15. Participation is limited to 15 men including conservation majors at the college and men teachers with undergraduate majors in biology or conservation.

The Speech Department is offering a five-week Eastern Drama and Theatre Tour of the eastern United States and Canada. Students will see over 20 plays and may earn up to six credits in speech and drama courses. Write Professor William Dawson for details. If you are interested in a 1962 summer tour of South America or a 1962 tour of Europe, write the college now for details concerning registration. Both tours will be credit programs.

Offerings have been expanded in the new Master's Degree program for teachers. Courses will be available in the sciences, social sciences, language and literature, education, art, music, and home economics. Write Dr. Burdette Eagon, Director of Graduate Study, for application forms and details of the program.

The American Historical Society and the college at Stevens Point are jointly sponsoring an institute for high school teachers of history. The emphasis will be on American Foreign Policy, retrospect and prospect. Free board, room, and tuition will be provided for 20 outstanding Wisconsin high school teachers who will be selected for this institute which will be held from July 10 to July 12. Write the history department for applications.

Summer school bulletins will be available in March. Those not in attendance in the 1959 or 1960 summer session may write for a bulletin. Students are urged to secure advance approval for their summer school program so that they may get into the courses of their choice. This will also avoid delays on registration day, June 12.

Fees for Wisconsin residents will total \$78. For further information write Dean Gordon Haferbecker, Director of the Summer Session, Wisconsin State College, Stevens Point.

#### Greeks Plan To Move In

Seven small dormitories are in the planning stage and should be ready for fall occupancy in 1961. Thrifty Builders of Milwaukee has embarked on a large scale college housing development program which is creating the most modern functional student housing possible at costs which do not exceed those in acceptable housing units. Anticipated costs will be about \$15. a week which will include room, board and other house expenses.

Groups presently making plans to move into this new housing development are: Alpha Sigma Alpha, Omega Mu Chi, Tau Gamma Beta, Alpha Beta Rho, Phi Sigma Epsilon, Sigma Phi Epsilon, and Tau Kappa Epsilon. Each group will have a house-parent who is officially in charge of the house and works closely with the student government within the group. The house parent is the adult counselor within the residence.

Each building has an attractive, completely furnished apartment for the house-mother or house-parents as the case may be. The apartment consists of a kitchen, bedroom, private bathroom, and carpeted living room. Heat, electricity, and water are furnished and the apartment is available to the house-mother without charge to her or the student group, for the entire calendar year.

The brick and stone buildings with appropriate amounts of exterior wood paneling may be designed as a 27 or 32 student house. The smaller house has 9 double rooms and 3 triple rooms while the larger unit consists of 16 double rooms. The basement in each house is an attractive and functional room for preparation of food, dining, meetings and social programs.

Construction of these buildings is to start some time before May, 1961. The land has already been acquired which is located between Division and Isadore Streets, immediately south of 4th Ave.

Students on campus are eagerly awaiting the completion of these housing units. This development can be a fine addition to our campus. We hope you alums will stop by and help us enjoy it.
