

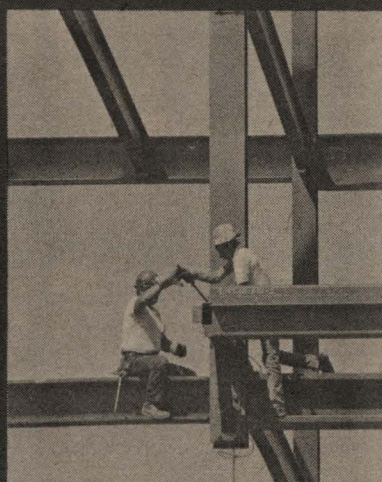

University honors its own

UW-SP honored outstanding graduates at several different events during 1984.

In March, State Sen. David W. Helbach, (D-Stevens Point), class of 1972, was named "Environmentalism of the Year" by the College of Natural Resources for his roles in spurring legislative action supporting ground-water protection, recycling, and environmental education.

At the same program, Charles Newby of Wausau, who serves as assistant superintendent of parks and recreation for Marathon County was named the "Outstanding Alumnus of the Year in Natural Resources." The 1964 graduate has been a state leader in the Wisconsin Parks and Recreation Association.

In April, the School of Education gave "Outstanding Practitioners in the Field of Teaching" citations to Elaine Tabor, second grade teacher in Merrill, graduate of 1966; Paul Wilsman, ninth grade science teacher in New Berlin, from the class of 1967; and Fran Calhoun, early childhood-special education specialist in Stevens Point, master's degree recipient in 1979.

Also in April, the School of Communicative Disorders named John Baumgartner, who received degrees in 1972 and 1973 at UW-SP, an "Outstanding Alumnus Award." Baumgartner was honored for his

successes in research, publishing and conducting professional workshops and conferences on the topic of stuttering. He holds a Ph.D. degree and now teaches at the University of Denver.

In May, William A. Bablitch, who attended UW-SP from 1959 to 1961, received the William C. Hansen Medalion in recognition of contributions to the improvement of society. A former Portage County District Attorney and majority leader of the Wisconsin State Senate, Bablitch has served since 1983 as a justice of the Supreme Court of Wisconsin. He previously received the school's "Distinguished Alumnus Award."

In June, George E. Cartmill, Grosse Pointe, Mich., class of 1938, was given the "Distinguished Alumnus Award" during the annual Alumni Day activities on campus. He retired last December as president and chief

executive officer of Harper-Grace Hospitals in Detroit, one of the largest facilities of its kind in the nation. He was president of the American Hospital Association in 1965-66.

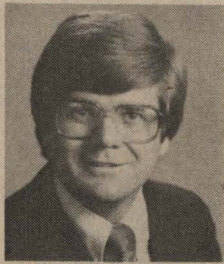
At the homecoming celebration in October, five sports stars from the past were inducted into the UW-SP Athletic Hall of Fame.

The five are the late Warren Becker, a football record-setter from 1932-34 who grew up in Green Bay; Jack Crook, Sussex, and the Rt. Rev. Msgr. Mark Schommer, Green Bay, football teammates who played from 1952-55 and 1950-53, respectively; and the late Bill Gelwicks, Freeport, Ill., who was a record-setting swimmer from 1963 through 1967 and Arthur W. Thompson, Wauwatosa, a three sport standout who excelled in basketball in the early 1930s.

Crook is a teacher and former

coach at Hamilton High School in Sussex; Father Schommer is director of administrative services for the Roman Catholic Diocese of Green Bay; and Thompson is a retired Milwaukee certified public accountant and Wauwatosa School Board member.

Also cited at the homecoming were Judi Janquart, class of 1970, physical education teacher and former women's basketball coach at Stevens Point Area Senior High who had a state championship team there; James Fitzgerald, class of 1968, new men's head basketball coach at Lincoln High in Wisconsin Rapids and formerly coach of three men's basketball teams at Park Falls High which advanced to state tournaments; and Fred Kestly, class of 1958, who has taught and coached at Pulaski High School the past 25 years where he now serves as athletic director. They received the "Excellence in Coaching Award" from the Department of Athletics. Robert Daniels, Cape Coral, Fla., who from 1950 to 1978 was the "Voice of the Pointers" as a radio announcer for WFHR Radio, Wisconsin Rapids, and Willis Zorn, who attended UW-SP in 1919 and 1920, and later was a star athlete at the University of Chicago and served about 40 years at UW-Eau Claire as a professor, coach and athletic director, both received the "UW-SP Athletic Director's Award."

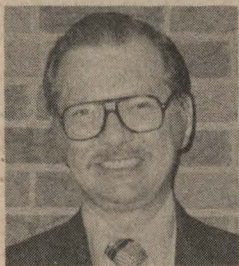

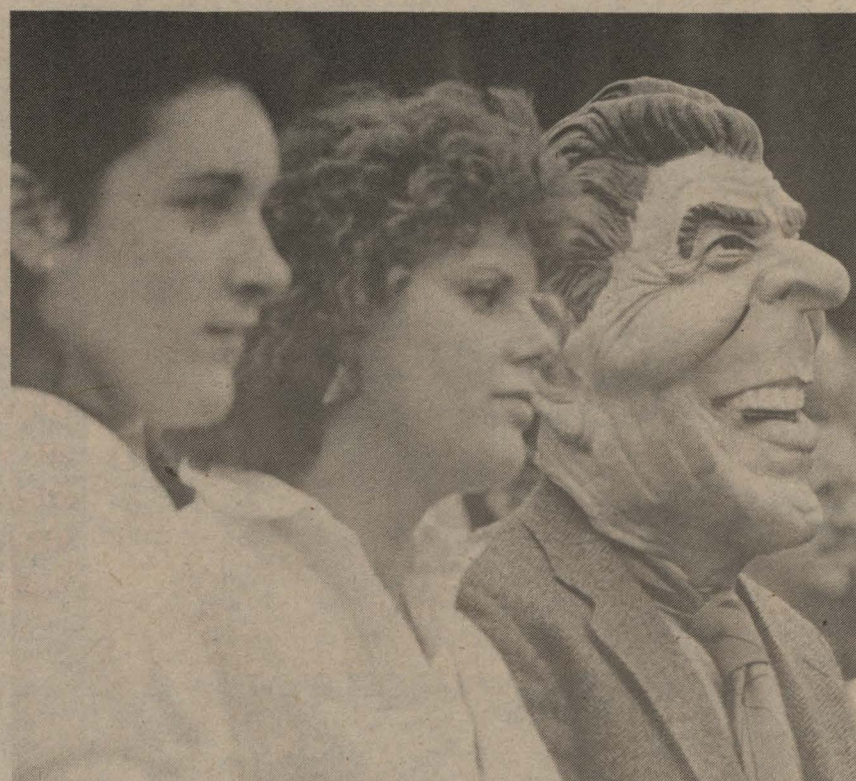

More than 30,000 alumni and patrons of UW-SP were invited to a no-dance prom this summer as part of the school's annual fund drive for student scholarships.

"Visualize yourself not suffering through tedious small talk, not eating a cold dinner with green beans, not being packed onto a crowded dance floor while listening to loud music and perspiring over your anti-perspirant, and not having your partner walk all over your newly polished shoes," the invitation stated.

The invitation also included an itemization of \$206.50 for costs of clothing, tickets, food and services not needed by a couple for the prom.

UW-SP enrollment returns to 9,000

The UW-SP fall semester enrollment is 9,007—close to the all-time high count logged three years ago.

It is several hundred larger than expected by campus officials and about 700 higher than the number projected some time ago by UW System officials in Madison.

In 1981, 9,209 people signed up for the fall semester. Last fall, the count was 8,871. Campus officials thought it would be difficult to maintain last year's enrollment in view of the fact the number of high school graduates in the state continues to decline. Consequently, they put on an aggressive recruitment effort. It more than paid off.

Three Elderhostel offerings scheduled

Elderhostel will be held for the eighth summer at UW-SP in 1985.

This is a program for people age 60 and older. Elderhostel has been called a total weeklong living/learning experience for older people. Hostellers live in our campus dormitories and can enroll in one to three specially designed courses.

A sampling of the courses to be offered in 1985 are: The Birds and Wildlife of Central Wisconsin, Going on an Archeological Dig, The Art of Being Human, Living Well and Enjoying Life, The Ice-Age Trail.

Tentative dates are: July 7-13 and July 21-27. The hostel fee is \$190 per week which will cover room, board, tuition and extracurricular activity costs. Information is available from Barbara Inch, Office of Continuing Education and Outreach by phone or letter.

of Wisconsin-Stevens Point Annual Fund," the invitation continued.

The 25 members of the UW-SP Alumni Association Board, including President William Horvath of the class of 1962, signed it.

The university adopted a gimmick in its fund drive last year in the form of a blue test book similar to those used for many years on campus. Questions were posed about UW-SP and answers were included, related mainly to financial needs of the institution. The follow-up mailing was in the form of notice of incompleting classwork. It was used as a reminder to those who had not made a contribution.

Karen Engelhard, director of alumni services, said the campaign raised more than \$20,000, an increase of nearly 45 percent over 1982. Because a novel approach to fund solicitation provided an extra measure of motivation to donors, Mrs. Engelhard said the association decided to continue with that approach this year.

Accompanying one contribution to the invitation was this letter from Mrs. Violet Polivka, class of '51, retired postmaster of Grand Marsh and a former rural teacher in Adams County.

"I am an octogenarian and have very few dates anymore. If I were asked to come I would probably drive up alone, maybe have an accident, and as a result lose my driver's license.

"As I love music, I would certainly attend the dance. I find that very few handsome, young men ask me to dance—so I would help decorate the walls for a few hours, then in desperation I just might try this new thing called break? brake? dancing. It is usually so dark in the halls that no one would see me anyway, and I would have no inhibitions. However, I might dislocate a hip or break a few ribs and have a hospital and a doctor bill to pay. So in my case you have under estimated the amount of money I would have saved staying at home.

Special consideration will be given to students who have demonstrated outstanding leadership and who have attended a Laird Youth Leadership Day which is held every other year at UW-SP.

Laird, formerly of Marshfield and now of Washington, D.C., and his foundation will finance the scholarships.

Since the mid 1960s, Laird has sponsored a leadership day program at UW-SP every other year for the top junior and senior students from high schools in the area of north central Wisconsin which comprised his congressional district.

Professor doing polymer research

Would you like to own a car with an engine made of plastic?

A chemist at UW-SP is helping the scientific community find new ways of producing materials that would make it possible to mass produce such devices. The engine is only one example of the kinds of things that could become commonplace if high strength polymers, such as plastics, could be perfected to withstand high temperatures for extended periods of time.

Professor John Droske is the recipient of a \$15,000 grant from the American Chemical Society Petroleum Research Fund to finance his independent studies during the next two years.

The sponsoring organization awards about 100 grants each year to finance research by younger faculty on American campuses. However, only 15 of the recipients are chosen from institutions that specialize in undergraduate instruction such as UW-SP. All other award winners represent Ph.D.-granting schools.

Droske has completed his second year at UW-SP. He received his Ph.D. in 1983 from Colorado State University.

Change made in food service

American Food Management, Inc. of Marshall, Mo., has been hired to operate food services at UW-SP.

The firm will succeed Canteen Corp. of Chicago, which declined to exercise an option of renewing its contract after having its operations on campus since last summer.

The new director is Dave Wilz, a UW-SP alumnus who was serving as director of Saga, Inc., when that firm lost its bid in 1983 to continue providing food services after being in business on campus for 13 years.

Radio station gets more juice

The student-operated radio station at UW-SP has increased its power to broadcast up to about 40 miles in all directions from the campus.

The Federal Communications Commission granted a request of WWSP-FM to have power increased from 300 to 3,610 watts and for the installation of a new broadcast antenna on the tower of local commercial station WXYQ/WSPT.

The station which can be monitored at 89.9 on the dial will have more wattage than any other student radio station in the UW System, according to James Haney, faculty adviser and general manager.

The station broadcasts 20 hours each day, signing on at 6 a.m. and signing off at 2 a.m. The format is progressive jazz and rock music, news, and public affairs programming, all without commercial interruption.

Scholtes said the station is famous for its annual trivia contest, the 54-hour marathon event which is certified by the American Trivia Association as the world's largest event of its kind. This spring the contest attracted more than 5,000 contestants from all over the country.

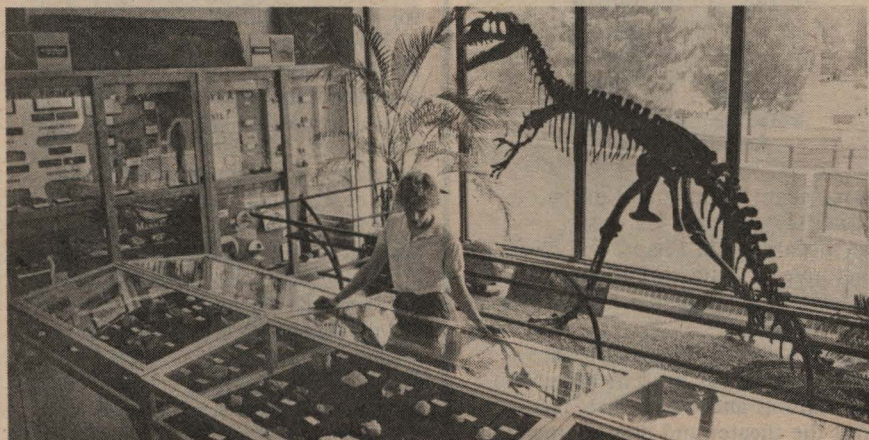

New Assignments, Programs

UW-SP gets new vice chancellor

Irving H. Buchen, dean of the School of Humanities at California State University in San Bernardino, is the new vice chancellor and dean of faculties at UW-SP, effective in November.

The UW System Board of Regents approved Chancellor Philip Marshall's nomination of Buchen to serve as the number two officer of UW-SP. Buchen will succeed Patrick McDonough who left during the summer to become an official of the Kellogg Foundation in Battle Creek, Mich.

Buchen, who has been in his present position for five years at an institution about two-thirds the size of UW-SP, was one of more than 100 applicants and nominees for his position here.

He said he is interested in forging "significant working partnerships between the university and its neighboring farm, business/industry and service organizations. He added that he would enjoy being involved in projects for Stevens Point urban renewal, downtown rejuvenation and in the

recruitment of industry to Portage County.

Buchen, a native of New York City, received a bachelor's degree in English literature and British history from New York University in 1952, an M.A. in American studies from the New York University Graduate School in 1955 and a Ph.D. in English and American literature from Johns Hopkins University in Baltimore, Md., in 1960.

He began his career as an educator in 1955 at Pennsylvania State University, teaching English composition.

For 19 years, prior to going to his present post in California, he served Fairleigh Dickinson University in Rutherford, N.J., rising in rank from instructor to full professor. He spent his past five years there as chair of the department of English and his last two years in the dual post of director of the Division of Future.

He was recently chosen as president of the California Council for Fine Arts Deans.

His other professional activities include being a consultant in the Thematic Studies Program at John May College and president of the 10,000-member Northeast Modern Language Association in 1973. Most recently, he and three other specialists were chosen to be honored in the Practitioner's Hall of Fame at Nova University in Florida.

All told, Buchen has penned about 40 scholarly articles and two books that were published by New York University Press: "Isaac Bashevis Singer and the Eternal Past" and "The Perverse Imagination."

Feldman leads philosophy unit

Richard Feldman assumed duties in August as chairman of UW-SP's philosophy department.

He has been on the faculty at UW-SP since 1971.

Feldman will succeed John Zawadsky who became the department's first chairman when it was organized 18 years ago and has served in the position continuously. Zawadsky, who did not seek reappointment, will resume full-time teaching.

The new chairman holds a Th.B. degree from Northern Baptist Seminary in Chicago and spent seven years as an ecumenical campus minister at the University of Illinois-Champaign and Urbana before returning to academe to pursue graduate study. He received a master's degree from Roosevelt University and a Ph.D. from Washington University in St. Louis as a specialist in the philosophy of law.

For approximately two and one-half years he served as a regular on "Morning Edition" aired by the Wisconsin Public Radio Network. He also has been executive secretary of the Wisconsin Philosophical Association for 13 years and was twice a vice chair of the UW-SP Faculty Senate.

Large U.S. grant for German study

"A total immersion into German language and culture," is the way the director of a summer institute at UW-SP describes the newly developed program.

Twenty-nine German teachers from throughout the state participated in the first institute session from June 18 through July 13 on the UW-SP campus. It was directed by Mark Seiler, chairman of the university's foreign language department.

This was the first in a series of three summer programs funded through a \$183,000 grant from the National Endowment for the Humanities. The grant, one of the largest ever received for a specific instructional program on campus, defrays nearly all of the expenses for a group of about 30 different teachers to participate in each institute.

The program has two lead instructors and five consultants and uses a communicative approach. There is ongoing use of the German language throughout the participants' stay on campus. They eat together in a private dining room, live in the same dormitory and attend classes in conversation, cultural history and teaching methods. In the evening they attend German movies and listen to guest presenters.

Seiler says this concept is part of the Council of Europe's push to develop new methods for teaching languages in the classroom. The teachers are learning how to get students involved in activity-oriented projects and "get at grammar in a functional way."

Information about next year's institute is available from Seiler.

Art, theater chairmen named

UW-SP has two new heads of academic departments who will assist in the development of programs related to career preparation in the fine arts.

Rex Dorethy, who has chaired the art department at Ball State University in Muncie, Ind., and Arthur Hopper, head of the theater and dance department at Milliken University in Decatur, Ill., filled similar administration/teaching posts at UW-SP this fall.

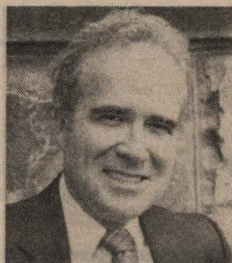
Dorethy succeeded Henry Runke who has been chairman of the art department for 23 of the 32 years he has served the university. Hopper followed Mrs. Alice Peet Faust who has been in charge of the theater arts department six of her 23 years on campus. Both incumbents requested to leave their positions and return to teaching, Runke on a full-time basis and Mrs. Faust, half-time.

Dorethy advocates continued development here of graphic, environmental and interior design and art education. Working with other departments to create some new courses is possible, he says, because of expertise now "ready to be tapped" in the division of communication and school of home economics. "I think we can develop some unique and very innovative programs in the visual arts," the chair continued. Dorethy urges the studio artists to continue to develop

their "already established pattern of aesthetic and cultural support to the department."

He has spent the past six years heading a department that had about 25 faculty members at Ball State. He had taught at the school since 1972.

A native of Macomb, Ill., Dorethy received his bachelor's degree from Western Illinois University in Macomb, his master's from Illinois State University in Normal and his doctorate in art education, also from Illinois State

though he did much of his course work at the University of Illinois.

He began his teaching career in 1959, serving first as an art supervisor for the Moline, Ill., public schools. After leaving there, he taught at his alma mater, Illinois State University before going to Ball State.

Dorethy is on the editorial board of "Studies in Art Education," a publica-

tion of the National Art Education, and is a consultant for the "Review of Art Research" from the University of Illinois Press, and "Viewpoints: Dialogue in the Visual Arts" published by Illinois State University. He has a lifetime appointment to the National Arts Policy Council. He has penned about 35 articles for publications and monographs. As an artist, he works mainly in painting and drawing.

Hopper is a native of Birmingham, Ala., with a bachelor's degree from

Birmingham Southern College, a master's from the University of North Carolina in Chapel Hill and a doctorate in dramatic literature and criticism from Indiana University in Bloomington.

He has served the past 14 years at Milliken, and was head of the communications and theater arts faculty until the theater and drama program

became a separate unit. Hopper has also spent seven years on the faculty at Indiana State in Terra Haute and three years at Troy State in Alabama.

In the professional theater, he spent one year managing and directing his own private stage in Estes Park, Colo.

Hopper has spent the past two years as president of the Illinois Theater Association which is an organization of professional, college/university, secondary education, creative dramatics/children and community theater personnel in the state. As a professional service, he also has been coordinator of the Illinois High School Association State Drama Contest for four years. He holds the title of "Outstanding Young Educator" for 1973 at Milliken.

Hopper has directed more than 100 plays. He says he most enjoys staging contemporary works based on historical characters. In February, he will direct "Abalard and Heloise" which is a 12th century story with 20th century language.

Hopper, who established the first musical theater program at an Illinois college or university, says he enjoys the kind of entertainment it creates, but prefers not to direct musicals.

The work done in musical theater at UW-SP is something "that attracted me here. I think it has a good future," he observed.

Institute to aid foreign students

A new institute to assist foreign students in learning English has been established and its first director appointed at UW-SP.

Richard Porior, a native of the Coleman area, was selected through a national search to head the English Language Institute (ELI). He formerly was director of an ELI Language Center in Superior.

Marc Fang, head of foreign student programs at UW-SP, says the institute is expected to be a drawing card for students from other countries. He says numerous foreign students who have studied here in the past could have benefited from taking classes in English as a second language. Students may either attend the institute before starting college classes or may study there while enrolled in university courses. Even if they come to UW-SP to study English, Fang says, the likelihood of them enrolling at UW-SP for their college studies afterward is great.

Foreign students are required to take the "Test of English as a Foreign Language" before being admitted to UW-SP. If people now score below the admission level, we won't have to

turn them down, Fang says.

Porior has been a longtime employee of Washington Educational Research Associates, Inc., Los Angeles, the agency that runs the ELI Language Centers. He began traveling abroad after he received his bachelor's degree from Maryknoll College, Glen Ellyn, Ill., in 1968.

He was an instructor at Maryknoll High School in Honolulu, Hawaii, and at Malabunga High School in New Guinea, and directed the Lao-American Association in Laos before returning to the U.S. for graduate studies.

After receiving his master's degree in Asian Studies from the University of Oregon in 1976, he directed a school in Taiwan. He served as an international franchise consultant for one year in Mexico City before taking over the school in Superior.

Porior, who spent a year in Taiwan studying Mandarin Chinese, is fluent in that language. He says it is not necessary to know the native tongues of the students in order to teach them English. It is necessary to use all of the teacher's talents to communicate, especially acting skills. He also utilizes role playing in the classroom.

Michigan educator new 'home ec' chief

Billie Lou Sands, a specialist in administration, curriculum development and family life, has been appointed head of UW-SP's School of Home Economics.

She assumes the position in August, succeeding Mary Jo Czapski who left this summer to become executive officer of the 5000-member National Council on Family Relations headquartered in Minneapolis.

For the past 10 years, Ms. Sands has served at Eastern Michigan University in Ypsilanti as chair of a home economics program similar in size to the one at UW-SP.

Ms. Sands was recommended for the post by a local search and screen committee headed by Grace Hendel of the School of Home Economics faculty. The appointment was made by Arthur Fritschel, dean of the College of Professional Studies, who said Ms. Sands has "outstanding credentials to serve as an administrator, especially in the area of budget and finance."

She has been involved professionally in home economics since 1962 when she received a bachelor's degree from Northern Michigan University and began teaching the subject at Lake

Orion High School. She later taught two years at Plainwell High, was an assistant instructor and graduate assistant at Michigan State University, and spent from 1970 to 1974 as associate professor of home economics education and family life at the University of Northern Iowa. She was acting department head there for two years before taking her last position.

Ms. Sands holds a master of arts degree and a Ph.D. from Michigan State University.

She has been active in professional organizations on the state and national levels and has had writings and reports of her research published in the areas of family life, vocationalism, consumer education, and competency-based education.

Engelhard promoted

Robert Engelhard, professor of forestry, has been promoted to the position of assistant to the dean of the College of Natural Resources at UW-SP.

While announcing the appointment, Daniel Trainer, dean, said Engelhard would serve one year during which time a review will be made of the administrative structure in the college. James Newman, who has served as the assistant to the dean since 1972, shortly after the position was established, requested to be relieved of his administrative duties for health reasons.

Engelhard has been active in the development of the forestry program at UW-SP. Before joining the faculty, he served a decade on the forest management staff of Trees for Tomorrow in Northern Wisconsin. He also has three years of experience with the U.S. Forest Service.

Haine temporarily heads business

James M. Haine, a corporate attorney turned professor, has been named acting head of the division of business and economics at UW-SP.

His appointment from Howard Thoyre, dean of the College of Letters and Science, was effective Aug. 1 and continues for one year.

Haine will succeed Robert Taylor who has been in the position the past three years and is leaving to assume a similar post at the University of Louisville in Kentucky.

He will teach part-time, handle administrative duties and be involved in the recruitment of a new head of the division, which has one of the fastest growing academic programs on campus.

Before joining the UW-SP faculty in 1976, he had experience as a corporate attorney, as a part-time teacher at Old Dominion University and as a computer systems analyst. He has done extensive research in patentability of computer programs, and done further specialization in the study of business law and state legislation.

Seven faculty retirements

Margery Aber - founder of Suzuki program

Margery Aber, who is credited with making UW-SP one of the country's foremost centers for the advancement of Suzuki Talent Education, retired in August.

During her 17-year-career on campus, she played out a love story as she directed her energies through the innocence, eagerness and natural abilities of very small children in helping them attain a high level of musicianship.

The Suzuki method involves instruction in string instruments, but its first purpose in education is to nurture love and peace among developing people.

Miss Aber literally left her position as director of the American Suzuki Talent Education Center of Stevens Point in a blaze of glory.

A record number of participants—more than 3,000—attended her annual summer institute from late July to mid August, coming from all parts of the globe. At the end they paid her several tributes.

The star of the three-week institute at UW-SP was Shinichi Suzuki, the venerable founder of the Suzuki method who came from Japan at age 86 to be a master teacher and to honor Miss Aber for her work in propagating his philosophy and approach to teaching in the United States.

In 1967, Suzuki was visited in Matsumoto, Japan, by the first American String Teachers Association tour group. Among the 55 educators was Miss Aber. In the intervening years, she has become one of the most active disciples and has traveled to different parts of the world to study with him and to assist him. Today, she is recognized often for making Stevens Point

the foremost center on the continent for the advancement of talent education.

A native of Racine and holder of degrees from Oberlin College and Columbia University, Miss Aber completed 30 years as a string teacher in the Detroit Public School System in 1967 and was eligible for retirement benefits. But she wasn't ready for retirement. The time was ripe, she recalls, for pursuing a dream of teaching on the collegiate level, so she interviewed for an opening on the faculty at UW-SP. She was offered the

position and signed her contract while in Japan under Suzuki's tutelage.

Miss Aber, an energetic 70-year-old, plans to remain involved with the program she founded by giving individual lessons. She also plans to do consulting for other schools which have or plan Suzuki offerings. Several years ago, she helped set up the first Suzuki programs in Europe at an institute in Belgium. In 1983, she was part of a tour group that took the Suzuki method to mainland China. Two of her star students, Charys Schuler and Elizabeth Wrone joined her. And her father, Earle Aber, then nearly 97, went along as a sightseer.

She has been complimented recently by receiving about six different job offers, but she's declining to try an easier daily schedule in her second retirement. Her students and parents have given her a 12-speed bike which she hopes to spend more time riding (she recently went on a 15-mile spin with friends) and gardening with her father, now a sprightly 98-year-old, at his home in Waterford.

Meanwhile, she has some dreams about the future of talent education at UW-SP.

She would like to see a major building constructed for the program, and for it to double as a permanent headquarters for the Suzuki Association of the Americas which was organized in Stevens Point more than a decade ago. (Miss Aber was one of the association's charter board members, and in 1980, she received its first distinguished service award.)

She also sees value in the expansion of the Suzuki method into UW-SP's teacher education program. Because this approach to teaching involves imitation and repetition, it has been

found to be especially effective in introducing children to such diverse disciplines as foreign language and mathematics.

Miss Aber would like more future parents exposed to the Suzuki philosophy. She contends it "doesn't matter which subject be approached, use of the Suzuki method helps develop the character of children so they can become more sensitive, selfless and loving people. Those things are the ultimate because when we have them, anger is eliminated and we have peace and harmony."

Miss Aber's name will continue to be synonymous with Suzuki in Stevens Point. The board of directors of the Suzuki Foundation has, through the years, raised \$100,000 to use in awarding scholarships in her name to UW-SP music students.

There was an apostolic succession, of sorts, at play in 41-year-old Paul Landefeld's recent appointment as her successor. Seventeen years ago, Miss Aber was officially sanctioned by Suzuki in Japan to carry forth his work in the United States, and she was involved in choosing and preparing Landefeld to carry on her responsibilities.

Landefeld attended the first Suzuki institute here in 1971 and most of them thereafter. He became Miss Aber's assistant director in 1983. A native of Pittsburgh, he holds the B.F.A. degree from Carnegie-Mellon University and the M.M.E. from Duquesne University. His experience includes being conductor for a student orchestra at the Suzuki's Talent Education Institute in Matsumoto and as a teacher at the International Suzuki Teachers' Conference in Amherst, Mass.

Guy Gibson - Civil War historian

Guy J. Gibson, a historian specializing in the study of the United States Civil War and Reconstruction, is retiring at the end of July after serving 27 years on the faculty of UW-SP.

He has changed his status from full professor to student and joined a group organized at UW-SP that is spending the fall semester in Taiwan and mainland China.

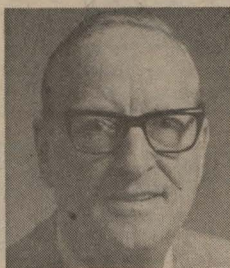
Gibson has had three distinct careers. He spent four years in the Army Transportation Corps during World War II and was employed nearly a decade as a writer/editor and editorial researcher in Chicago before coming to UW-SP in 1957.

The Wheaton, Ill. native, who grew up on farms in the Mountain-Gillett-Oconto Falls area, had several relatives who did social work, including an uncle who was head of the Cook County public welfare program in Chicago. So, Gibson decided to pursue a similar career and was graduated from UW-Madison in 1936 with a major in group social work. However, his first job was for a Chicago publishing company that prepared house organs for organizations.

Later, he rose to the rank of company officer and first lieutenant while spending most of World War II

in New Guinea and the Philippines.

After his discharge, he returned to Chicago and was employed in editing and research for the Union League Club, an organization made up largely of Republican businessmen interested in supporting "better government." The league's beginnings pre-dated the Civil War and was a booster of Abraham

Lincoln's brand of politics and took a strong stand against slavery. Gibson's research into the group's records piqued his interest in history and led to his decision to enroll at the University of Illinois in Champaign-Urbana, where he received his master's and doctor's degrees.

He did his dissertation on political anti-slavery.

Besides his teaching at UW-SP, Gibson has been active in joint efforts of the American Historical Association and Organization of American Historians to combat a decline in the value society places on the study of history, particularly in schools. He was the Wisconsin member of a national "Committee on the Status of History in the Schools" and wrote the state of Wisconsin's section of its report.

He says he "fears" there has been "some weakening in the teaching of history." However, he commends the UW-SP faculty and administration for doing "less cutting in history requirements here than in most places." He adds: "This school is known for its strong history programs."

Gibson also has been long active in The Association of University of Wisconsin Faculties (TAUWF) and has been vice president of the local chapter. He is a former acting chair of the history department, past president of the United Ministries in Higher Education (cooperative organization of several Christian denominations supporting religious programs for UW-SP students), former member of the Faculty Senate, and longtime adviser to Phi Sigma Epsilon fraternity. He was a faculty leader for two

different semester abroad groups, one to Poland and the other to England.

In the community, Gibson has been active in the Portage County Republican Party and a member of its board of directors, and a 16-year board member of the Portage County Historical Society including a six-year stint as president. He received the society's highest recognition, the "Pine and Iron Award" in April.

After spending his adulthood in the study of history, who are his favorite figures from the past? Abraham Lincoln and "Fighting Bob" LaFollette stand high in his estimation, but he gives special praise to one who has become somewhat obscure—Zachary Taylor. The 12th president showed signs of greatness as a national leader, Gibson contends, because he was "moving in the right direction" on a tough political issue during a volatile time. Before dying halfway through his first term in 1850, Taylor had blocked the expansion of slavery into the new western states.

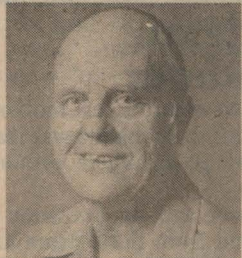
"That was quite an accomplishment for a former military man who was considered to be pretty rough, and for one who had been a slave holder," the professor muses.

Orville Rice - mathematician

Orville M. Rice, senior member of the mathematics/computer science department faculty at UW-SP, retired at the end of the spring semester after serving the institution for 28 years.

He has been a specialist in calculus and pre calculus.

The 66-year-old Rice was born and reared on a farm near Toledo, Ill. He came a long way in education in view of two close calls with becoming a drop-out. In the depths of the Great Depression, he waited two years

following grade school to enroll in high school, and then deferred to farm duties for a year between high school graduation and his freshman year at what today is Eastern Illinois University in Charleston. With a new bachelor's degree about the time World War II began, he was commissioned as an ensign in the Navy,

received training at the U.S. Naval Academy in Annapolis, and served much of his duty in the South Pacific as a meteorologist. He forecast weather for Navy pilots and advanced to the rank of lieutenant.

He began his teaching career in 1945 at the high school in Martinsville, Ill., and later served at Blue Mound, Ill., before becoming a graduate student at the University of Illinois in Champaign-Urbana. He then spent four years on the faculty of Flat River Junior College in Flat River, Mo., prior to his arrival in Stevens Point.

Rice, who did doctoral level study at UW-Madison after joining the local faculty, taught both physics and math in his early career here. And, he utilized his collegiate experience as a runner to revive a defunct Pointer cross country team and coached it for three seasons.

The longtime professor has been active in faculty governance, having served as an officer of the faculty and as a member of its senate. He also has been active in The Association of University of Wisconsin Faculties and served for a time as local representative on its state executive committee.

Rice and his wife, Marjorie, live at 832 Indiana Ave. They have four children and seven grandchildren.

His plans are "to learn to fish again" and after a year, he may do some part-time teaching.

Calvin Schmid - chemist

The second retirement in his life went into effect in May for Calvin H. Schmid. But he didn't leave the work force altogether.

For 20 years, he served in the U.S. Air Force and for the past 21 years he has been a member of the chemistry faculty at UW-SP.

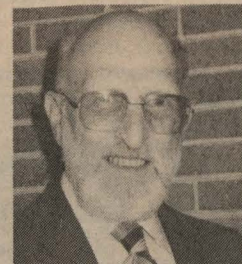
He is planning, however, to do some part-time teaching on campus for the next few semesters.

Schmid and his wife, Norma, who have lived in Stevens Point and at a year-around home on Catfish Lake near Eagle River, are both natives of Plymouth. He is a member of a family of ministers and was one of few men in his immediate kinship to step beyond the career path of a cleric in the former Reformed Church now the United Church of Christ. His grandfather, father, and uncles were ordained and his son, Michael Joe, is a staff member for the Navigators in its ministry to military personnel.

Schmid joined the armed forces in 1943 after graduating from UW-Madison. He worked in photo intelligence, special weapons, research and development, and teaching. He retired with the rank of major, having spent the last 3½ years at the faculty of the U.S. Air Force Academy in Colorado Springs, Colo. Earlier, some of his research was done for the development of materials that could withstand high temperatures for use

in the pioneering space flight by Astronaut John Glenn.

Schmid, who spent most of his time during World War II on Guam with the

20th Air Force, logged a total of seven years on foreign soil while in the military, mainly in Western Europe, Japan and Guam.

His attitude about the controversial arms buildup is one which he always has maintained: "Our surest way of not getting involved in another war is being more ready than anyone else."

Schmid, holder of a master's degree from the University of Texas in Austin, joined the UW-SP faculty in 1963 and has spent most of his time since teaching freshmen. He says his department attracted "a good crop of them" through the years and that their students have been coming to campus in recent years with better preparation in their high schools.

The professor plans to devote more time in retirement to hobbies.

Stafford - peacemaker

David B. Stafford, whose lifetime has been spent advocating peaceful solutions to human conflicts, has retired as a professor of sociology/anthropology at UW-SP.

He has served UW-SP for 15 years, including a six-year stint as chair of his department.

Stafford is a southerner by birth who has childhood recollections of uniformed Ku Klux Klan members in rallies and cross burnings. The experience may have sparked his interest in propaganda and public opinion which he plans to continue pursuing in retirement by writing a textbook on the subjects.

The professor who is the son and grandson of North Carolina Sheriffs, adopted his mother's religion in the Society of Friends. As a young Quaker and World War II approaching, he became educational director for the Selective Service's special program for conscientious objectors. Later he spent three years in China, near its border with Burma, as part of a Society of Friends ambulance unit.

As an educator, Stafford holds a bachelor's degree from Guilford College, a master's from Haverford College and a Ph.D. from Duke University. As a doctoral student at Duke University, he was chosen for the prestigious designation as a Phi

Beta Kappa scholar.

His first teaching post was at George School, preparatory to Swarthmore College in Pennsylvania, in 1939. After returning from China, he spent from 1947 to 1969 on the faculty of Guilford College, near Greensboro, where he was department chair before coming to Stevens Point.

With his degrees in history, psychology and philosophy as well as sociology/anthropology, he is an advocate of a liberal arts emphasis in education. As a pacifist, he has drawn his student's attention to humane concerns, universal values and aspirations.

Stafford's Chinese experience led to his study of the Chinese personality and culture and his development of courses in those subjects.

In community life, he was involved in efforts to improve race relations. Since coming to Stevens Point, he has been one of the organizers of a group of Quakers which now meets regularly.

He also has helped promote better global understandings of UW-SP students as the leader of two semester abroad groups to England.

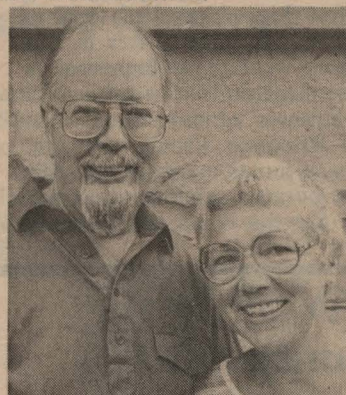
Mrs. Gerson - musician

A commendation has been given by UW-SP to Marjorie Phelps Gerson, who has served on the faculty of the institution the past 18 years.

She retired recently, and upon the unanimous vote of her teaching colleagues in the music department, she has been given the honorary title of associate professor emeritus and cited by Chancellor Philip Marshall for "exemplary service." Mrs. Gerson taught vocal music here since 1966, on a part-time basis since last year.

John, Lee Bernd - educators

Together, they've spent more than a century either as students or teachers. So John and Verlene (Lee) Bernd, husband and wife, believe it's now time to be involved in something other than education.

He is retiring as an education professor at UW-SP and she is leaving her post as an English teacher at P.J. Jacobs Junior High School.

Their swan song from their careers is as leaders of a UW-SP program in Taiwan and the People's Republic of China during the fall semester.

When they return in December, they will take up residence at a home they have purchased in Atlanta.

Bernd is a native of Oconomowoc who grew up in La Crosse and received his college education at UW-La Crosse. He began his teaching career 40 years ago at West Salem High School, and decided the following year to pursue a master's degree at UW-Madison where he had a research assistantship in history. In 1946, he joined the faculty of Merrill High School as an English and civics teacher.

Mr. and Mrs. Bernd left Merrill for South Milwaukee in 1952 where he taught three years and she, two years. While he pursued a doctorate

at UW-Madison as a fellowship student, she earned a master's degree in library science one year and taught another year at Belleville High.

Bernd entered the field of higher education in 1957 as a faculty member at William Patterson State College in Haledon, N.J. He later served from 1958 at Wayne State University in Detroit where he was chair of the social studies education department and assistant director of admissions and records. He came to UW-SP in 1964, where his career has included a five-year stint as head of what is now the School of Education.

About a decade ago, when a Wisconsin Title IV Advisory Council was formed to advise the Wisconsin Department of Public Instruction on its expenditures of federal aid for special educational projects, he was chosen as the first chair and served several terms. Later, he was elected head of the National Association of State Advisory Councils.

He also served on the Stevens Point board of education.

Mrs. Bernd, a native of Chippewa Falls, started her career after graduating from UW-Eau Claire and has since logged 35 years as a teacher. She was on the high school English faculties in Black River Falls and Plymouth before going to Merrill where she met her husband. In addition to her other aforementioned assignments, she taught children's literature at Wayne State University five years and at UW-SP for 11 years. She has taught for the Stevens Point Area School District the past nine years.

The couple's wanderlust was encouraged in 1973 when they led a UW-SP group in a semester in England. In 1975, he was the leader of the university's first group to Poland. They also led two summer tours of England, in 1975 and 1978.

Business students cited

A group of business students from UW-SP won top honors in a three-state competition to promote the free enterprise system.

Their prizes, in addition to citations, included \$1,800 in cash.

With 10 other public and private colleges and universities from Ohio, Michigan and Wisconsin, the UW-SP group won the "best entry" competition and one of three "best new entrant" awards in the Student Economic Leadership Forum.

The presentations were made at the Center of Free Enterprise in Ada, Mich. The Amway Corp. is joined by

Dow Chemical, Whirlpool Corp. and Federal Mogul Corp. in sponsoring the annual event.

In addition to the prizes won by the total group, two students were each honored for submitting two of the four highest rated personal job resumes. The \$150 prizes in this category went to Al Binnebose, a senior management specialist within the business administration major from Wisconsin Rapids, and Joel Tracy, a junior marketing specialist in the business administration major from Stevens Point and formerly of Port Edwards.

Accounting grads tops in exam

Graduates of UW-SP have honored their alma mater through successes in writing the November of 1983 state examinations to become certified public accountants.

As a whole, the UW-SP alumni ranked number one in the percentage of those taking the examination for the first time and passing all four sections in the first writing.

Five of seven of the UW-SP graduates writing for the first time passed the entire exam—a 71.4 percent success rate. Though the number of graduates in this group was smaller than the number representing most other public and private colleges and universities, the success rate far exceeded the composite scores of the alumni from sister schools.

Of 454 people in the total pool writing the exam, the success rate in all four parts was 35.7 percent.

Information about the exams is routinely announced by the Accounting Examining Board of Madison which administers them twice each year.

UW-SP hosts Cameroonians

A national convention of students in the United States from the African nation of Cameroon was held July 26 to 28 at UW-SP with a diplomat as the keynote speaker.

Paul Pondi, Cameroon's ambassador to the United States, addressed more than 200 delegates.

The students discussed political, economic and cultural/educational issues now being addressed in their homeland. Cameroon recently experienced an unsuccessful attempt by the military to topple the existing government.

National prize

Rae Barnes Canfield has received a national award for leadership and community/campus service from Phi Upsilon Omicron honor society for students of home economics.

The Sarah Thorniley Phillips Leadership Award included a prize of \$300.

Advertising Club keeps winning

UW-SP's student advertising club continues to win national recognition.

This spring it again won regional competition and then finished the year with an eighth place finish among 15 teams vying for honors at the U.S. contest in Denver.

The club, known as The Adventors, was judged number one at a regional event for the fourth time in five years. The prize was a trophy and a trip for five student presenters and two faculty advisers to attend the national convention of the American Advertising Federation where the finals were held.

The student presenters were Tony Utrie of Green Bay, Larry Schmitt of Madison, Jennifer Faber of Stevens Point, Ellen Roeseler of Nekoosa, and Jodie Fischer of Wausau. Larry Kokkeler of the communication faculty and Richard Choyke of the business/economics faculty are the advisers.

A total of 35 members of the Adventor's Advertising team were involved in the development of the project since last fall. They created a campaign for Tandy/Radio Shack TRS-80 line of microcomputers.

Tandy officials requested the 129 colleges and universities which are members of the American Advertising Federation to design an ad campaign aimed at top managers of the Fortune 1,000 companies.

The Stevens Point students compiled a 50-page book of plans detailing for Tandy the background and rationale for their suggestions. They also prepared a 20-minute presentation explaining their proposed ads and promotions.

Forensics winner

Don Everts, a UW-SP sophomore from New London, advanced to competition this spring in three different events at the National Forensics Association Tournament.

The event was held at Georgia State University in Atlanta in April.

Everts, a communication and drama major, qualified for the nationals in January while at a tournament at UW-La Crosse. His coach was Mrs. Janet Newman of the communication faculty.

\$5,000 raised for charities

A group of students at UW-SP raised nearly \$5,000 by dribbling basketballs to DePere on April 13 and 14.

Proceeds of "The Rainbow Connection" project went to Community Industries in its support of developmentally disabled people living in this area.

The funds are being used for the purchase of equipment and to defray part of the costs of sponsoring a local group at the Lions Camp for the handicapped near Rosholt.

Six men and six women from Thomson Residence Hall at UW-SP were in a running and dribbling relay that began in downtown Stevens Point and continued to St. Norbert College in DePere.

Top arborist in Wisconsin

Steven R. Ruffolo, who is majoring in urban forestry at UW-SP, was chosen as the outstanding student arborist in the state by a professional organization.

He was honored by the Wisconsin Arborist Association at its convention in Stevens Point.

Academic turnabout

Peter Newberry's best motivator to improve his study habits was realizing "you can't go anywhere without an education."

A decade ago, his academic rank was second from the bottom among 510 graduates of Lincoln High School in Wisconsin Rapids.

In August, he was the number one scholar among 175 degree recipients at summer commencement at UW-SP.

This fall, he is at the University of Nebraska in Lincoln with a full scholarship to pursue a law degree.

Republican group best in state

The UW-SP College Republicans received the "best club of the year award" this spring from the state organization of the same name.

The 45-member local group is headed by Diane Engelhard of Stevens Point.

The UW-SP club was cited for a high level of activity throughout the past academic year, which has included "adopting" a Marine in service and writing to him, holding a candlelight vigil in memory of the Marines who were killed by terrorists in Lebanon last fall, holding a fast in protest to mistreatment by the Soviet Union of people there wishing to migrate to the United States, participating in a state model legislature in Madison and sponsoring a talk by former hostage in Iran, Kevin Hermening.

Plaudits for two Indian students

UW-SP has announced the first two recipients of associate degrees under a special program for adult Native American tribal members.

Betty Jack, Webster, and Richard Wolfe, Rt. 2, Stone Lake, have completed academic work which is the equivalent of half of the courses required for bachelor's degrees.

Ms. Jack and Wolfe are among about 50 people who have been pursuing the associate degrees since UW-SP's Native American Center began arranging courses on Friday afternoons/evenings and all day Saturdays on 10 weekends each semester.

Martha St. Germaine, counselor and adviser for the program, said she expects another eight to 11 people will be eligible for the associate degrees next May.

Ms. Jack and Wolfe commuted the longest distances, approximately five-hour drives one-way from their homes in the far northwestern corner of the state. In another way, she came an even greater distance, Ms. Jack is a recovered alcoholic.

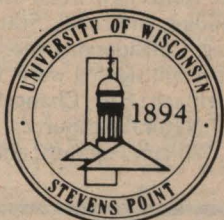
Faculty honor given to eight

For scholarship and research, the winners were Hamid Hekmat in the psychology department since 1968 and Charles Long of the biology department since 1966.

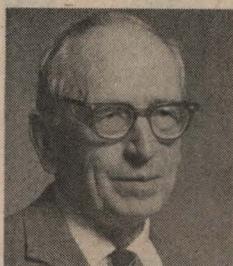
The service award went to Justus Paul of the history department since 1966.

Teacher, student share prize

An English and communication major at UW-SP is among 31 winners in the United States of a "Bedford Prize in Student Writing."

Daniel S. Dietrich, whose hometown is Red Wing, Minn., was one of 1,200 entrants in the competition from 500 colleges and universities.

His essay brought honor not only to himself but to his professor and to UW-SP.

Dietrich's work was published in an

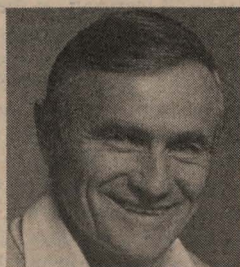
The competition was sponsored by St. Martin's Press of New York City which published the anthology.

Marcus Fang, lay leader for the Wisconsin Conference United Methodist Church, was recently elected vice president of the lay leader's organization of the general (national and world wide) church.

Miller heads state arborists

A new system of controlling insects on urban trees and shrubs, which could sharply reduce pesticide use, is being considered by the Wisconsin Arborists Association.

Robert Miller, a professor of forestry at UW-SP, is president-elect of the 220-member group which, he says, "hasn't officially endorsed the system but is quite interested in it."

Instead of doing routine spraying, the system developed at the University

of Maryland involves commercial arborists monitoring insects on trees and shrubs and spraying only when necessary.

"It's believed to be a less expensive way to go," Miller adds.

Members of the association discussed the "integrated test management" system during a recent annual meeting in Stevens Point where Miller was chosen to be their next president, effective in 1985.

Miller reports that the association discussed a new variety of elm that is resistant to Dutch Elm Disease. Developed by Gene Smalley of Madison, the hybrid trees are being released by the state nursery this year.

English teachers elect Heaton

A spring graduate of UW-SP was chosen as one of the two "Outstanding Student Teachers of the Year" awards sponsored by a state organization.

The recognition given to Elizabeth Jo Benedict of Racine is from the Wisconsin Council of Teachers of English.

In addition, UW-SP's Professor Helen Heaton was installed at the meeting as president of the 500-plus-member organization.

Miss Benedict completed a 10-week student teaching experience at Benjamin Franklin Junior High School in Stevens Point this spring where Jan Allen was her supervising teacher.

Cravens wins forestry award

The state chapter of the Society of American Foresters has given its highest award to Jay Cravens, a faculty member in the UW-SP College of Natural Resources the past eight years. Cravens received the John Macon Award of Merit for "outstanding contributions to our nation's forests and to forestry in Wisconsin."

The award memorializes a former Rhinelander and Wisconsin Rapids man who spent many years working in Wisconsin forests for Consolidated Papers. It has been given only about two times previously, and one of those recipients is a retired forestry professor, William Sylvester.

Cravens joined the UW-SP faculty after retiring as one of the top ranking

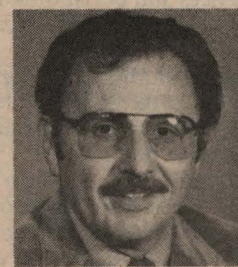

During a career of more than 25 years as a federal employee, he spent six years in charge of forestry operations in the U.S. Eastern Region which includes a 29-state area with headquarters in Milwaukee.

Athletic director's work applauded

She had moved from Stevens Point to 14941 Limonite St., N.W., Ramsey, Minn., last fall, to live at the home of her nephew, Michael Hartz.

Memorial funeral masses were held at St. Stephen's Catholic Church in Stevens Point and at Immaculate Conception Catholic Church in New Richmond.

Her body was donated to medical science.

A memorial fund for student scholarships was established with the UW-Stevens Point Foundation.

Miss Padden served UW-SP from 1960 until 1972 as librarian of the Campus Laboratory School and as a library science professor. Since her retirement, she held the honorary title of emeritus professor of learning resources.

Born July 11, 1907, at Erin Corners near New Richmond, she was the daughter of Mr. and Mrs. James Padden. She received a bachelor's degree from the College of St. Teresa in Winona, Minn., a master's degree from Florida State University in Tallahassee, and did additional academic work at several other universities in Wisconsin and the western United States. She also attended a secretarial school in Madison.

During a 44-year career, Miss Padden was a high school teacher of English and other subjects in Hustisford, Neshkoro, Pulaski and New Richmond. She also was an elementary school librarian in West Allis for seven years before coming to UW-Stevens Point. In the late 1920s, she traveled throughout Iowa by train as an employee of a company that sponsored home talent plays. She directed the productions. She worked for a time as a secretary for the State Medical Society of Wisconsin in Madison and as a federal office employee from 1938 to 1943 of the Farm Credit Administration in Washington, D.C.

Miss Padden was a past president of the Children's and Young People Division of the Wisconsin Library Association and a former member of the board of consultants of the state radio station's program, "Book Trails" which provided recreational reading guidelines for thousands of state children. She belonged to many professional library and teaching associations.

Her survivors include four nephews and two nieces. Her parents, one brother and one sister have died.

Two funeral services held for Miss Goldberg

Professor Toby Goldberg, 46, a specialist in film criticism and history on the UW-SP communication faculty, died Aug. 27 shortly after being admitted to St. Michael's Hospital.

She had been in failing health for several years and succumbed after suffering a heart attack.

Miss Goldberg, who lived at 1300 6th Ave., had taught at UW-SP since 1971.

Her body was returned to her hometown in North Adams, Mass., where services and burial took place. A memorial service was held on campus on Sept. 14.

Colleagues of Miss Goldberg established a fund with the UW-SP Foundation for either a student scholarship or lecture series in her honor.

Born Aug. 6, 1938, in North Adams, Mass., she received a bachelor of science degree in broadcasting and a master of science degree in communication arts from Boston University and a Ph.D. in communication from UW-Madison.

Before coming to Stevens Point 13 years ago, she had been an interviewer for the American Research Bureau in Beltsville, Md., a publicity writer for a public relations agency in Boston, a continuity writer for WHA Television in Madison and a teacher and research assistant at UW-Madison.

Miss Goldberg was named the outstanding communication arts student of 1961 at Boston University and was the recipient of a Ford Foundation Fellowship in 1968 at UW-Madison.

She wrote the book, "Federico Fellini: A Poet of Reality" which was

published in 1964 by Boston University School of Communication Press. She compiled a bibliography of the writings of and about Marshall McLuhan published in 1968 by the Journal of Broadcasting, and she and her brother wrote the television play, "Dialogue with a Wounded Lion" presented on the NBC Television Network in 1965 as part of the "Dr. Kildare" series.

At UW-SP, she was one of the founders and early faculty advisers of the University Film Society which sponsors public showings of film-art classics and foreign movies.

In 1975, after participating in the International Film Festival in Berlin, Germany, she lamented that much of the finest film art produced abroad was not making its way to the United States. Part of the problem, she concluded, was that many foreign flicks in the 1950s and 1960s attracted audiences for their sex scenes; consequently, many of the movie houses where they were shown in this country turned into showplaces for pornography. She said that while American films are technically excellent, foreign films "are made with more serious intent than just to be commercially successful."

She was a past president of the Stevens Point Chapter of Hadassah, a philanthropic organization of Jewish women.

Her survivors are her mother, Mrs. Ida Goldberg of North Adams, Mass.; one sister, Mrs. Pamela White of Worcester, Mass.; and one brother, Dr. E. Marshall Goldberg of Flint, Mich.

Tree planting honors artist

A 15-foot sugar maple—the official state tree—was planted in Arbor Day ceremonies in April on the lawn of Old Main as a tribute to UW-SP's first art teacher.

Members of the Stevens Point Chapter of the Daughters of the American Revolution purchased the sapling and conducted a ceremony in honor of the late Mary Ella Tanner.

In 1894 when UW-SP opened as a State Normal School, Miss Tanner, a native of the Berlin area, was part of the original faculty. Three years later, she became a charter member of the local DAR chapter and was its first historian.

Miss Tanner taught drawing on campus until 1901, with the exception of one year when she was on leave of absence to represent the Wisconsin Free Library Commission in an extensive tour throughout the northern part of the state. "I lectured on the use of pictures and showed librarians how to use them in libraries and school room decoration," she later wrote. She also spent some of the year in New York studying with a sculptor and visiting schools there and in Boston.

Her interest in promoting the circulation of pictures and art in traveling libraries was considered innovative—something that did not become commonplace locally until about a decade ago.

Little is known of her life before she came to or after she left Stevens Point, except for these facts: she was graduated from the high school in Berlin in 1888; was an art instructor and supervisor in Marinette and Duluth before her arrival; studied in Boston and at the Pratt Institute in Brooklyn; married Thomas R. Croswell after leaving here and later lived in Greeley, Colo., Pasadena, Calif., and Bloomsburg, Pa. Family information and the date and place of her death are not known.

Several members of the UW-SP Student Society of Arboriculture assisted in the ceremony at which brief talks were given by Mrs. Raymond Schull, regent, and Mrs. John Barnes, conservation committee chair of the Stevens Point DAR chapter.

Longtime library staffer succumbs

Mrs. Loretta Vrobel Kampenga, who served 18 years on UW-SP's library staff prior to her retirement in 1974, died of cancer Aug. 25 at St. Michael's Hospital in Stevens Point. She was 79.

Her funeral was held Aug. 27 at St. Joseph's Catholic Church in Stevens Point followed by burial in the parish cemetery.

The daughter of John and Magdalene Sager, she was born in Stevens Point on June 30, 1905, and attended local schools, graduating from the Stevens Point High School.

From 1925 to 1942, she was secretary to the founder of the Joerns Furniture Company of Stevens Point. Her first husband, Edward Vrobel, was a salesman for the firm. The couple spent nine years of their marriage in Chicago before returning to Stevens Point in 1956. He died the following year.

At the university, Mrs. Kampenga served as secretary and assistant to the librarian from 1956 to 1966 and then as an associate archivist until her retirement in the spring of 1974.

She and Professor Emeritus Nelis Kampenga, a widower with whom she had a longtime professional association at UW-SP, were married June 28, 1974.

The couple resided at 1109 Sunset Blvd., Stevens Point.

Mrs. Kampenga's survivors include her husband; one daughter, Mrs. James (Carol) Wintercorn of Chicago; one stepdaughter, Mrs. Amy Peterson of Whitewater; three sisters and two brothers; six grandchildren; one step-grandson; one great-grandson.

Grafs start new life in Switzerland

John Philip Graf, his wife, Lois, and their two small children now live in Switzerland where he is employed in a hardware store. The family returned to Wisconsin to visit relatives this summer, at which time they visited UW-SP where he was graduated in December of 1972. He provided this article about his experience of starting a new life in a new land.

"Didn't things go well for you any more over there?" and "Is it any better here than there?" are questions I've been answering for nearly two years. "Over here" is Uetendorf, Switzerland. "Over there" is Monona, Wisconsin, a long way from here. "Is it far from South America?" and "What part of Canada are you from?" are frequent questions as well. I explain: Wisconsin, in the U.S.A. In general terms, north of Chicago. "Ah, yes, Chicago..." and the average Swiss knows exactly where we used to live.

It isn't a lot different from the questions we heard in 1982, when we announced that we were moving to Switzerland. "Oh, Sweden, where everybody is blue eyed and blonde haired," or often this: "Switzerland? Do you speak Swedish?"

It seemed as if no one knew where we were going, then later, no one here seemed to understand where we came from. Not many could understand why we moved. Why would we give up everything, at the drop of a hat, so to speak, and move to a foreign country where we didn't even have a place to live or a job lined up? Imagine, Lois gave up an R.N. career, and I was general manager at Community Newspapers. We sold, gave away or threw out the majority of our belongings. We booked a one-way ticket, packed four suitcases and two small overseas trunks, said our good-byes and, with Bethli, then 1½ years old, left for an adventure.

Perhaps the story really begins in mid 1949, when my father came to the U.S. from Schaffhausen, Switzerland, to see a little of the world before getting married. In January 1950, his fiancée came from Uetendorf to get married in New York. Together they struck out for Wisconsin, where they now live north of Appleton.

Uetendorf has about 5,000 residents at the foot of the Bernese Alps, some three miles from Thun. Bern, the capitol of Switzerland, is about 15 miles north of us. The snow mountains are 25 miles away and present a pleasant background for this mostly rural area.

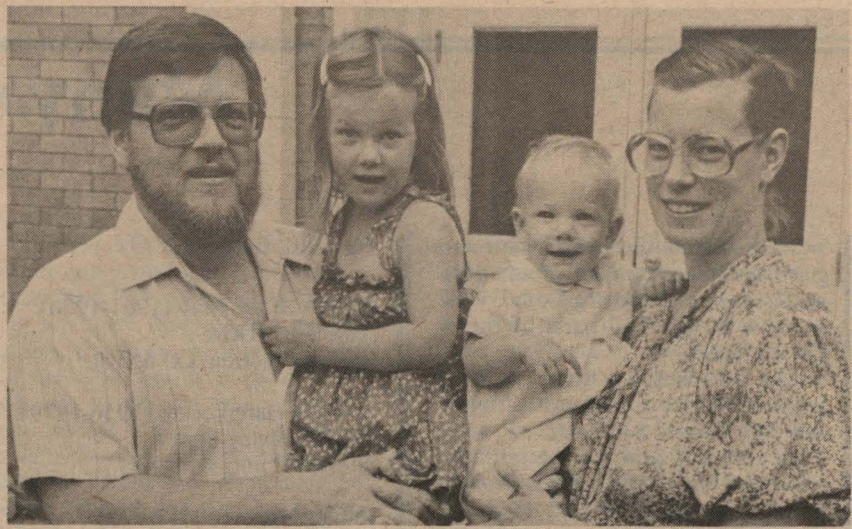
We live in an old farm house, in the village, surrounded by new one-family houses, a five unit apartment building, and two other older farm houses. On one side of our house is a sheep pasture with four or five cherry trees in it, on the other side is a hay field with three apple trees and across the street, another sheep pasture. Each field is the size of a small residential lot in a Wisconsin city, about 75 by 75 feet.

Our plumbing consists of hot and cold running water at the kitchen sink—the hot water heater is a 2½ gallon electric unit. Our bath tub is a 25 gallon galvanized tub which we store on the back porch. The toilet is out back, beside the house.

In January 1980, Lois and I visited relatives in Schaffhausen and Uetendorf. I felt very much "at home" in the old homeland that I'd learned about from my parents. On the way home, in the airplane, I asked Lois if she would like living in Switzerland. Her enthusiastic yes had us discussing the venture all the way back home. My responsibility was to write to the Swiss Consulate and learn of our status as Swiss citizens. Swiss law allowed citizenship to pass from the Swiss father to his children and his foreign-born wife. Having been born and raised in the U.S., I wasn't sure this applied to us anymore. Days turned into weeks, two years went by and I still hadn't written that letter. Lois, meanwhile, wisely decided not to hold her breath until I wrote.

Then, in January 1982, I finally wrote. We learned we were Swiss citizens as well as American—dual nationals they call us. We could have passports from both countries, if we wanted them, and we were free to live and work in "our" country just like any other Swiss born and raised here.

There was no good reason for not making the move. We looked at the adventure in the same way one might look at a move across the U.S., from New York to California. We were

going just a little farther.

Though Switzerland is highly industrialized, housing such as ours is quite easy to find, particularly in the country.

Our central heat consists of a wood-burning stove in the kitchen connected to a sandstone structure in the living room and bedroom. The fire heats the kitchen, and this structure, which acts as heat storage, emits a pleasant warmth throughout the day. We used about 1½ cords of wood and 5 cubic feet of coal last winter.

We've found that we've made a complete change in our lifestyle. Life here is no better, nor any worse than in Monona. While we are very happy here, we still call Wisconsin home.

For one thing, living in any new place is very much a matter of getting used to the way things are here. Goethe said: "To live is to adapt." There are any number of hurdles in the way—none of them large enough to cause us to turn our backs and come home. I was exposed to enough Swiss culture during my youth in

Wisconsin that I've never felt out of place here. Lois is remarkably adaptable. She mastered the language in short order and isn't afraid to be with the people.

My father never had a "good reason" as a pat answer when asked why he came to the U.S. He now explains our move as "discovering our roots."

That wasn't the plan, but has been the fruit of our adventure.

Through this radical change in our life, we've discovered the peace of spending more time with each other and the joy of taking more time with the children. We've gained a new perspective on life.

We have had the chance to experience first-hand the goodness of God and the care and protection He offers us. We left Monona knowing that there were things that could go wrong—no jobs, no place to live, difficult adjustments—but we also knew that God would help us. All we have to do is trust Him.

Creative way to give

Selling Stocks at a Profit? Send the Capital Gains Taxes on a "Detour"

Are you planning to sell some of your securities at a long-term gain? Then you are probably painfully aware that part of your profit will be swallowed by broker fees and capital gains taxes.

Many of our investor friends would be delighted if the UW-SP Foundation could receive the tax collector's share. There is a way to accomplish exactly that result: a bargain sale of securities to the Foundation.

What is a bargain sale? It includes any sale or exchange of property between an individual or corporation and a charitable organization in which the charity gets more, so to speak, than it gives up.

Take the case of Katherine who bought a stock years ago for \$2,000. It is now worth \$10,000. If she tells her broker to sell the stock, she will have an \$8,000 long-term capital gain, of which \$3,200 (40%) will be taxable. In her 50% tax bracket she would owe \$1,600 in taxes. So she keeps only \$8,400, and that's ignoring any broker fees.

Katherine can sell the stock to the UW-SP Foundation at a bargain price, make a satisfying gift, deprive the

IRS of any capital gains taxes, and still keep a substantial amount of the proceeds. Furthermore, she will pay no fees to a broker. Here is how it works:

Katherine sells the stocks to the UW-SP Foundation for \$7,575.76, an amount we calculate using simple algebra. The difference between the market price (\$10,000) and the \$7,575.76 we pay her is a tax-deductible charitable gift; \$2,424.24. Her \$8,000 capital gain would have to be prorated between the gift and the sale price under the IRS "bargain sale" rules. Katherine winds up reporting \$6,060.60 of long-term capital gain. Only 40% of the gain is taxable, of course. And 40% of \$6,060.60 is, you guessed it, \$2,424.24, which is erased by her charitable deduction.

Obviously, Katherine keeps more with a straight sale of the stock through her broker: \$8,400 plus broker fees versus \$7,575.76. But she has the satisfaction of giving the Foundation the tax collector's \$1,600 share... and ends up making a \$2,424.24 gift for only \$824.24 out-of-pocket cost. This is "planned giving" at its best!

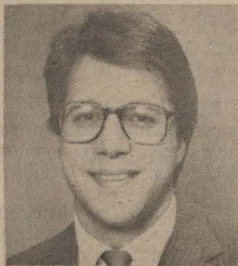

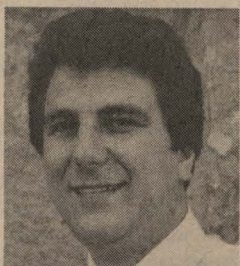

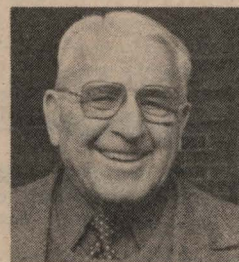
