Staying in step with change

The following article was submitted to *The Milwaukee Journal* for possible publication as an Op Ed piece. The article responds to a recent "Journal" editorial on a critical report from the Wingspread Group on Higher Education entitled "An American Imperative." The report outlines a number of serious weaknesses in the education offered by our nation's universities. My response provides evidence that UW-Stevens Point has not gone the way of the campuses cited in the report. This is not to say that we take the findings of "An American Imperative" lightly. We will continue to make changes in line with its recommendations. Nevertheless, UW-SP's alumni and friends will be pleased to read how well our campus, in general, measures up to the standards of this landmark study.

Op Ed piece for *The Milwaukee Journal*

On January 10, 1994, you published an editorial which called "An American Imperative," the recent report by the Wingspread Group on Higher Education, "a helpful prod to higher education." At the University of Wisconsin-Stevens Point, we, too, took the report seriously, and, while we find some of its suggestions useful, we were especially gratified to discover that UW-Stevens Point in no way fits the image of the "campus in decline" described in "An American Imperative." Quite the contrary, a comparison of some of the report's key recommendations for higher education, with prevailing practices at UW-SP, demonstrates how successful our university has been in preserving the higher education virtues extolled by this group of experts:

1. "An American Imperative" claims that education is organized to convenience educators rather than students, and that the quality of undergraduate education is being sacrificed to accommodate faculty research.

At UW-SP, our primary focus is on effective undergraduate instruction. Our students are taught by highly-qualified, full-time faculty who regard student learning to be their top priority. While many of our faculty are involved in research projects, their research typically enhances their classroom teaching, and they sometimes involve their undergraduate students in research activities. For example, during the summer of 1993, we set an all-time record in placing 55 of our biology students in research positions. And for a second

consecutive year, our university is leading nationally in the number of research grants our students have received under the prestigious internship program sponsored by the U.S. Department of Energy.

One of the best tests of the quality of undergraduate education at UW-SP lies in its consistently high placement rates. In good times and bad, more than 95 percent of our graduates find work or continue their education in graduate or professional schools.

2. "An American Imperative" reports that academic requirements are not demanding enough to give college graduates a broad education. For example, among all college graduates in 1992, 26.2 percent had taken no history; 30.8 percent, no math; 39.6 percent, no English or American literature; and 58.4 percent, no foreign language. The Wingspread Group strongly recommends a core curriculum of liberal arts for every college student.

UW-SP has held firmly to requiring of all students one of the largest liberal arts components of any campus in Wisconsin, public or private. Every UW-SP student completes coursework in history and English. And the campus's writing emphasis program requires six credits of writing classes beyond freshman English. All students must demonstrate proficiency in math. Some of our students do not study a foreign language. We agree with the report that a good case can be made for requiring foreign language proficiency of all students. In recent years, a special Curriculum Task Force has reviewed general degree requirements at the university to ensure that they provide the content and skills essential for students in the new century. We will soon begin to implement new, even more rigorous degree requirements which will include the serious study of ethics for all students.

3. "An American Imperative" criticizes the failure of universities to collaborate with public elementary and high schools, and with area businesses to the mutual benefit of all participants.

UW-SP has been hailed by former U.S. Secretary of Education, Lamar Alexander, and current Secretary of Education, William Riley, as a national model of how universities and schools should collaborate. For example, our campus was named the lead institution in a grant to work with other Wisconsin universities in preparing emergency-licensed teachers to teach special education in the public schools; we have provided computer access to three university libraries for the students of Stevens

Point Area Senior High; we have entered into a historic agreement to help create a new two-year college on the Menominee Reservation; and we have established a partnership with First Financial Bank of Stevens Point to provide UW-SP students on-the-job experience, and the opportunity to work with banking professionals.

In January, we received the "Decree of Excellence" award from the Stevens Point/Plover Area Chamber of Commerce for our contributions to the vitality of the local economy.

At UW-SP we are grateful for the report from the Wingspread Group because it provides some helpful recommendations and independent confirmation for much that we are doing and plan to do. The evidence clearly shows that UW-Stevens Point does not fit the stereotype of higher education "in decline." Nor does this stereotype fit any of our sister institutions in the University of Wisconsin System. Nevertheless, we admit that the road ahead is uncertain. We will need to take more students, keeping the costs to them and to the state at a minimum. This means reduced administrative costs, improved use of technology, and better assessment of what our students are learning. We strive for constant improvement, and we are moving forward to prepare young people for life in the twenty-first century in a dynamic and responsible way.

In March, I issued a Chancellor's report to UW-Stevens Point constituents that presents more details on the university's achievements over the past five years, and the challenges which lie ahead. I want everyone who is interested in our university to receive a copy of this "state of the university" document. It is my belief that the more people know about UW-SP, the more they will appreciate its many qualities. ■

UW-SP has 21st century classroom

UW-SP has a new "21st Century Classroom" with the potential of revolutionizing how teaching is done.

Opportunities for learning therein "may end teaching as we know it today," said Joan North, dean of the College of Professional Studies, who initiated the project.

UW-SP received nearly a quarter of a million dollars in grants from the state through its laboratory modernization programs and other appropriations to finance the classroom.

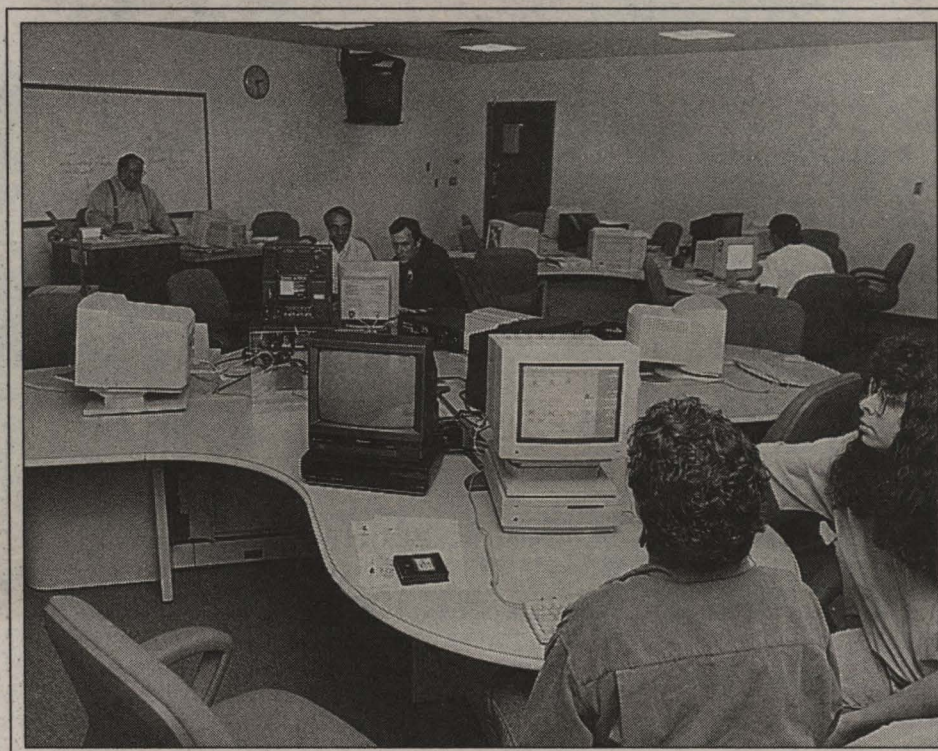
Much of the cost went into the purchase of computing equipment and software, laser printers, hookups to information networks and the remodeling and furnishing of the space. Nearly 250 different kinds of software are available.

Located in Room 105 of the Professional Studies Building, the classroom is drawing interest from faculty across campus who are in awe of its capabilities, according to Larry Riggs, an education professor who coordinated the planning and is now overseeing its use.

He expects to receive a large number of requests from professors in a wide range of academic disciplines to take classes there.

Named a "Collaborative Learning Center," it is designed to encourage cooperative work between students. The variety of software is appropriate for classes ranging from kindergarten to the university level.

The "classroom" employs multimedia with the computer, making it possible for students to study a subject by watching parts of films, viewing pictures, listening to audiotapes and then using the same materials in the development of reports. ■

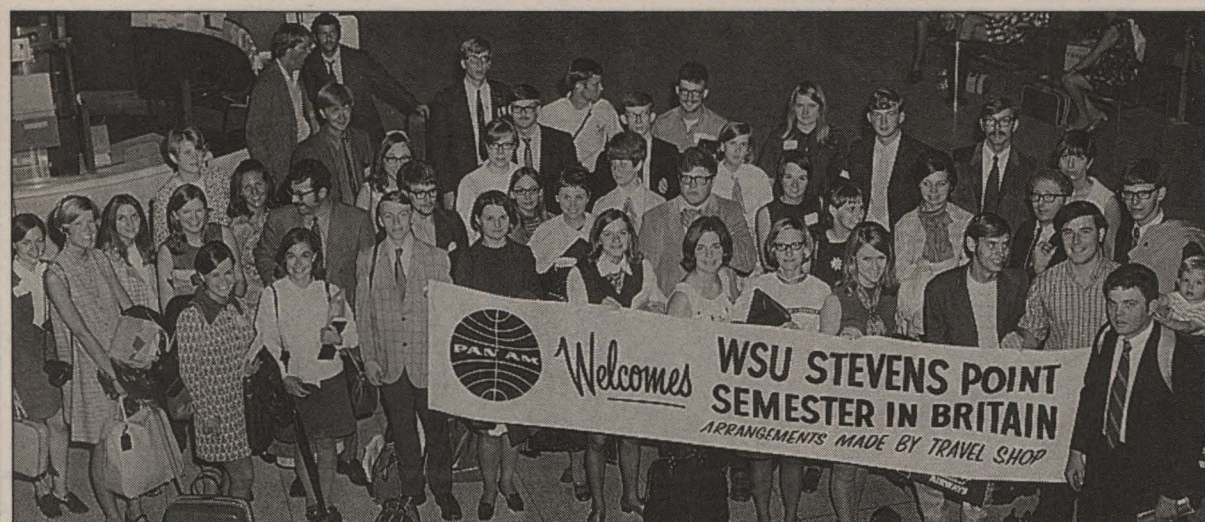

International program reunion set

The Office of International Programs, marking its 25th year of study tours abroad, invites its approximately 5,000 alumni to attend a reception following the Homecoming parade on Saturday, Oct. 1.

Former leaders, students and International Programs staffers will meet from 11 a.m. to 1 p.m. in the University Center Wisconsin Room for the sharing of photographs, scrapbooks and stories.

The program's debut tour to Great Britain in 1969 was organized and directed by Pauline Isaacson, a history and speech professor, with the support of then Chancellor Lee Sherman Dreyfus. One of the leaders of that group was Professor Emeritus Alan Lehman, who retired from the English faculty in 1986.

Writing from his home in Arizona, Lehman recalls, "We were all excited but a bit apprehensive too, for here we were the first of many groups, as it turned out, to be going to Europe to study, to live together, to meet people and to acquire different kinds of culture from that dreamed of by most of the students. We were on trial! And during the four months or so we were overseas, the group was very much aware of this mission, of their being the first and of setting good precedents." He also reports of this group of students, "As it turned out everyone ultimately liked everyone else and the last I heard six couples were still married at our 20th reunion."

With that first contingent in 1969, Dreyfus and Isaacson, the two global visionaries, began an endeavor that has blossomed into a worldwide academic enterprise with affiliations in 26 countries providing overseas study opportunities for more than 300 students collectively traveling well over 125,000 miles per year.

As director until 1982, Isaacson nurtured the program's growth to include several new sites in Europe and the Far East. She was succeeded by Helen Corneli of the English faculty, who, over six years, guided the development of new locations in Greece, Australia and the South Pacific.

Robert Bowen, a health education specialist, has been the director since 1988. Under his leadership, programs have been established in France, expanded in East Germany, and new locations have been developed in

Spain and China. Bowen is assisted with the program's administration by staff members Mark Koepke, Linda Garski and Linda Mirr.

In commenting on the program's history, Bowen especially commends the more than 200 faculty members who have served as leaders and contributed to its 25-year success story. He cites members of the natural resources faculty for their involvement in administering several of the tours, including those to Australia, a summer program in Poland and Germany and an interim experience in Costa Rica. He mentions faculty in foreign language who have helped develop language immersion programs, fashion and interior design teachers who conduct various overseas experiences to fashion capitals of the world and business and economics faculty which lead a summer program to Great Britain and financial centers on the continent. "International experience for UW-SP students is rapidly becoming an integral part of the curriculum as our university fulfills its responsibility in preparing students for their career in the global community," Bowen comments.

"One of the most significant developments in international education is the fall of communism which opened the Berlin Wall and subsequently opened all borders in Europe. The effect on study abroad has been to open new opportunities for students studying in Europe and Europeans studying in the U.S."

He also marvels how transoceanic communication such as e-mail and fax have transformed and streamlined the coordination of an overseas campus. Details that used to take weeks can now be accomplished in one day.

He credits UW-SP administration for their ongoing cooperation and support of the program, as well as the associates abroad who have given UW-SP's faculty and students so much time and attention.

Bowen encourages all students and faculty who have traveled abroad during the past 25 years to return to campus, relive their memories and renew their friendships at the Homecoming reception this fall. ■

Polymer chemistry endorsement sought

UW-SP is working to have one of the nation's first 10 certified undergraduate instructional programs in polymer chemistry.

The new offering is being developed as an option of its chemistry major.

Because of growing opportunities for scientists in this field, "we think it is important our graduates can work in it," according to Jack Reed, chair of the Department of Chemistry.

UW-SP has been a leader in the state in educating science students about polymers.

Two members of the university faculty are experts in the field of polymers—John Droske and Paul Hladky. Courses in that subject have been on the books at UW-SP for about a decade, a polymer laboratory has been built in the Science Hall, and the university has been designated the POLYED National Information Center for Polymer Education.

Plans for the new option have been approved by the UW-SP Faculty Senate and await the okay of the UW System Board of Regents.

Stevens Point graduates are moving into leadership positions in this industry through advanced education. Five alumni—Bill Joseph, originally from Glidden, Veronica Reichert, Bancroft, Eric Fossum, Black River Falls, Paul Engen, Westby, and Peter Elliker, Stevens Point—are working toward or have completed Ph.D. degrees from the leading polymer schools in the country.

The university has received considerable outside support for its leadership in developing new polymer programs. The laboratory is believed to be the only one of its kind in the state for undergraduate students. The National Science Foundation and the American Chemical Society Polymer Division have invested a total of several hundred thousand dollars for instructional materials. The POLYED Center has brought national attention to the university for its service to educators throughout the United States. ■

Faculty salaries pulled from bottom

Chancellor Keith Sanders said in December he will work to bring salaries of all UW-SP faculty and teaching academic staff into the mid-range of the UW System wage scale by next year.

Speaking at a faculty meeting, he explained how reallocated funds from the school's operating budget have been used in the last few years to improve the pay for people who teach here.

When he arrived at UW-SP, Stevens Point faculty were receiving some of the lowest salaries in the state's university system. Now holders of the professor title rank fifth among the 11 schools devoted to undergraduate instruction. Those who are associate professors are up to fourth place, he reported.

Sanders said the university has, in the last few years, reallocated more than \$1.1 million from its operating budgets to bring salaries here more in line with the money received by faculty at other UW institutions. ■

Water resources chapter named best in country

UW-SP was the 1993 winner of the Outstanding Student Chapter of the Year Award from the American Water Resources Association.

Earl Spangenberg, faculty adviser, said this is the fourth time UW-SP has won the recognition since it was established in 1983.

The association is a professional organization whose mission is to provide an information exchange, an interdisciplinary forum for education, and cooperation on water resources issues.

Spangenberg said his students have contributed to the AWRA efforts by sponsoring field trips to water laboratories, assisting in community service projects such as Habitat for Humanity, encouraging academic excellence by choosing an outstanding water resources student among underclassmen (the award went last year to Jay Gear of Fremont, Ind.), and arranging social activities, including a skydiving experience for members.

Six students joined Spangenberg at the annual conference last summer of AWRA in Tucson, Ariz., where the award was presented.

The AWRA has nearly 4,000 members in 53 countries. There are 28 state chapters and 19 student chapters. In 1976, the UW-SP chapter was the first such unit organized. ■

Government documents section lauded

Uncle Sam is a hero to UW-SP librarians who are experiencing the frustration of maintaining an up-to-date collection of books and periodicals in times of severe financial constraints.

Great about the federal government in the eyes of Margaret Whalen, who heads the government documents section of the UW-SP library, is that "it doesn't stop publishing in times of budgetary crisis."

Best of all, the materials come free.

Housed on the sixth floor of the James H. Albertson Learning Resources Center, the approximately one million items in the documents unit account for almost half of the total library collection on campus.

Growth of government-sponsored publications is at the rate of about 30,000 titles per year, according to Whalen.

Her clientele goes far beyond students and faculty. Because the library is the only depository for

government documents in a wide area of the state, it attracts patrons from an equally large area.

The diversity of document subjects is a draw to the library in itself, according to Whalen, but the fact they are now on the computerized card catalog is making them even more available to users.

Not all of the publications are from the last 40 years since the collection was begun. Previous librarians, including Nelis Kampenga and Arthur Fish, did much to locate from other libraries the more important government documents that date from the earliest days of the federal government.

Whalen says, "we have an incredibly complete collection" with many of the publications of a "rare book" nature. These publications date from the early 1800s. ■

Student praised for work on diagnosis of Alzheimer's

A UW-SP biology student did much of the research during the past summer on a National Institutes of Health project to develop a test which determines if people are at risk of Alzheimer's Disease.

Victoria Lubierman was a senior when she was invited to serve at NIH in Bethesda, Md. as an intern.

During her assignment, she was part of a four-member team that discovered certain potassium pathways are missing from cells in nasal cavities of people with Alzheimer's.

Dr. Rene Etcheberrigaray, a staff researcher in charge of overseeing Lubierman's experiments credited her with doing about 50 per cent of the work on the project. He said that her contributions were "very unusual for a student."

The paper she and her three fellow researchers have developed was scheduled for publication this spring in the "National Academy of Sciences Proceedings."

"It's just fantastic, said one of her professors, Kent Hall of the UW-SP biology faculty. "No faculty member in the history of this university has published findings in the Proceedings," he added. "Now one of our students has done it."

Lubierman, who completed requirements for her bachelor's degree in December, has returned to the National Institutes of Health to continue more Alzheimer research.

The nasal cells Lubierman studied are linked to the central nervous system. Scientists expect to find similar characteristics in skin cells. That discovery could lead to a simple lab test for Alzheimer's, Dr. Etcheberrigaray said.

Lubierman has received numerous honors for her academic achievements at the university. But her most prestigious recognition came at the end of last summer when she was one of 16 honorees from among 180 research fellows at the NIH's Institute of Neurological and Communicative Disorders and Stroke. She was given the exceptional Student Award. In addition, she was one of six research fellows chosen to present a paper to her colleagues about her research of the Alzheimer diagnosis.

After working at NIH this spring and summer, she hopes to enter a medical school this fall. Her goal is to earn both a P8h.D. and an M.D. which will qualify her to do research and be a practicing physician. ■

Botany students study at ancient site

Each semester a UW-SP biology professor and his students take a journey back in time 66 million years to a prehistoric dried-up lake bed in Central North Dakota.

Botanist John Curtis and a group of students embark in the spring and fall on a weekend pilgrimage to a spot near Bismarck, N.D., where ancient plant life has been preserved under nearly pristine conditions.

Curtis says the original lake was at least a mile in diameter and apparently surrounded with flora that thrived in the semi-tropical climate. Sentinel Butte, which now stands guard over the region, is the only surviving landmark from that ancient terrain. Over the years of visiting the area, the research teams have discovered a variety of well-preserved fossils of leaves, fruit, seeds, flowers and fish species that apparently began to thrive after the dinosaurs had disappeared.

Upon their return to campus, Curtis and his student assistants use an electron microscope to scan, magnify (up to 135,000 times), and photograph the fossils in order to solve the mysteries of these ancient plants.

The university students' treasures from their field trips are displayed on the first floor of the College of Natural Resources, while others have been installed in a new exhibit at the entrance to UW-SP's Museum of Natural History. ■

Radio station marks 25th year

In the fall of 1968, student radio station WWSP 90FM, celebrating its silver anniversary this year, began broadcasting from a studio in Old Main. It has developed over the last quarter century into an enterprise involving 13 paid staffers and about 80 volunteers who broadcast a variety of music, news, sports and public affairs shows from 6 a.m. to 2 a.m., seven days a week, 365 days a year.

The station's signal, which now originates in a studio in the Communication Arts Center, covers a 60-mile radius throughout central Wisconsin. Its announcers play every kind of music imaginable, including rock, blues, jazz, folk, ethnic music and heavy metal. It has exclusive broadcast rights for Pointer Hockey games, airs nine news shows daily, and features specialty programming such as "Culture Talk," "University Spotlight," "Earth Awareness," "Club Wisconsin" and an annual fall "Jazzfest," featuring 56 consecutive hours of jazz classics.

This semester, in honor of the station's birthday, a Silver Anniversary Lunchbox, a half-hour of music by a select group from each year of the station's history, began on Feb. 14 and ran until March 18. The first group from 1968 was the Beatles and the last group was the Red Hot Chili Peppers. Each day a listener won a free lunch at an area restaurant and the final drawing named a grand prize winner of two free

nights at the Elizabeth Inn, two dinners at Shooter's Restaurant and 25 compact discs.

Another ongoing event this semester has been a show called "Evolution," aired every Tuesday from 6 to 7 p.m. The program is a historical perspective of news, music, sports and entertainment over the past 25 years.

An alumni appreciation banquet on April 9, marking the anniversary, kicked off the the 25th annual Trivia contest this spring at the UW-Stevens Point.

The weekend of April 8-9 was the warm-up for WWSP 90FM's "Trivia Park: An Adventure 25 years in the Making," 54 hours of Trivia mania, which drew about 11,000 players the weekend of April 15-17.

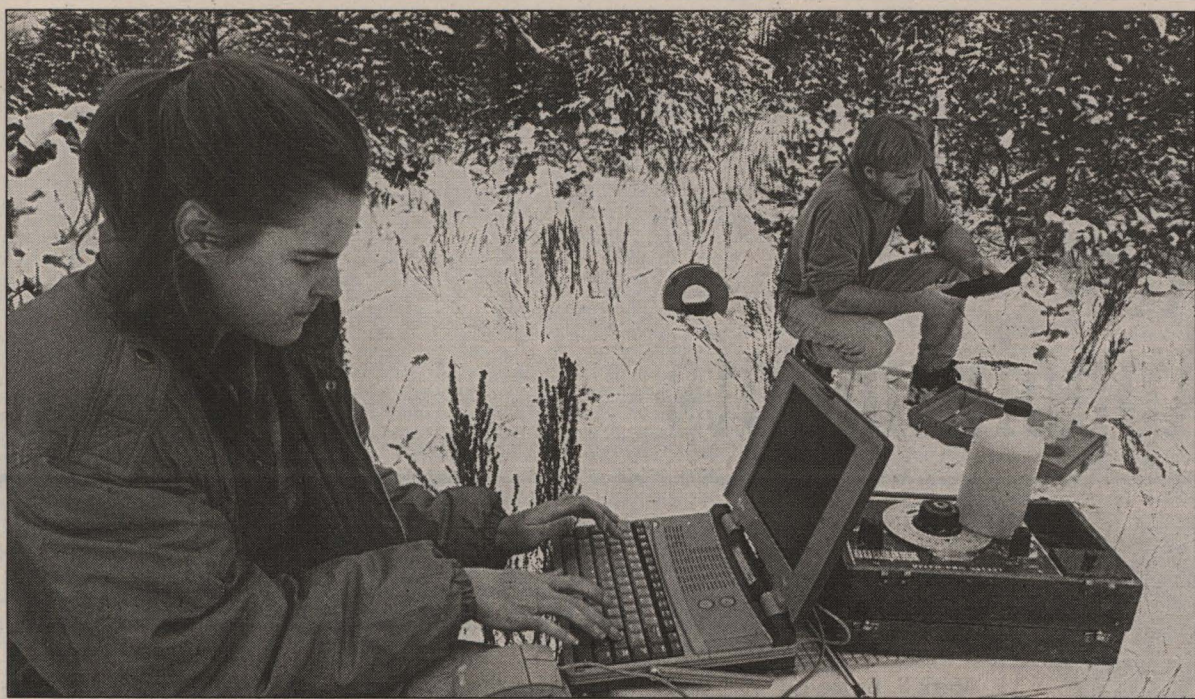
Radio station alumni from throughout the country (and the world) were invited to a dinner in the University Center Laird Room on the evening of April 9. Following the banquet a Trivia Kickoff Movie was shown at Rogers Cinema at midnight.

Also that weekend, on Friday, April 8, Greg Koch and the Tone Controls, a Milwaukee-based blues trio, headed by a UW-SP alumnus, performed in the Trivia Kickoff Concert.

In May, an anniversary "Vinyl Toss," co-sponsored by the UW-SP Frisbee Club, features the launching of old long-playing record albums. Contestants who

throw the discs the farthest and the most accurately win prizes. A softball game co-sponsored by the Residence Hall Association also is being planned for the end of the school year.

The station's public relations director publishes a monthly newsletter which is mailed out to station alumni seeking names, addresses, and updates on the many people who have been involved with student radio over the years. Endowments honor two students

Two endowments totaling \$45,000 have been established with the UW-SP Foundation to provide scholarships for future wildlife students.

The funds are memorials to Erik Munson of Ames, Iowa, and Douglas Stephens of Peoria, Ill., both of whom were graduates of UW-SP in 1991.

Relatives and friends provided the money that is being invested to support annual awards and scholarships in Munson's and Stephens' names. Winners will be announced at each spring's College of Natural Resources recognition program.

Approximately 110 donors donated the \$25,000 for the Stephens fund after he died in January of 1992 while tracking black bear in the Chequamegon National Forest in northern Wisconsin. He had just completed his bachelor's degree in wildlife the month before and was beginning work on his master's degree from UW-SP.

Munson had been named one of the top wildlife students in the College of Natural Resources at the university for three consecutive years prior to his

graduation. At the time of his death in Champaign, Ill., he was pursuing a Ph.D. degree at the University of Illinois.

His parents, brother, sister and several other relatives and friends provided a \$20,000 fund in his memory. ■

Frat house proceeds will fund scholarships

The approximately \$18,000 profit from the sale of a fraternity house here has been donated to the UW-SP Foundation to support student scholarships.

The property at 1517 Brawley St. had been owned by the Chi Delta Rho/Sigma Phi Epsilon Alumni Corp. A student chapter of this group no longer exists here.

Half of the gift will be used to generate interest monies for the Chancellor's Choice Scholarship Fund for high-achieving students entering the institution.

The other half of the gift is endowed to generate interest monies for distribution to men and women who are members of fraternities and sororities on campus. ■

The UW-SP Foundation has a new president and a major increase in its assets.

Don Kropidlowski, president of American Equity Bank of Stevens Point, was elected in October to head the charitable body that raises funds in behalf of special scholarships and special projects at the institution.

The foundation collected a total of \$1.6 million in its fiscal year that ended June 30. The income was up nearly \$600,000 from the previous year and brought the total assets of the organization to \$3.6 million, according to the report of treasurer Robert Hanes of Wausau.

Kropidlowski, who received bachelor's and master's degrees from the university in 1964 and 1974, has been active in a variety of ways in support of UW-SP. He recently was president of the Academy of Letters and Sciences.

Kropidlowski succeeded Gerald Viste of Wausau, who held the presidency two years. Viste will remain as director in the past president position.

Sharon Nemirow of Wausau was chosen as the new vice president; Hanes and Gene Katz of Plover were re-elected as treasurer and secretary, respectively.

New board members are Raymond Hutchinson of Weyauwega and Thomas Mack of Wausau.

Re-elected as directors were Hanes, Katz, Kropidlowski, Alan Malm of Merrill, D. David Sebold of Medford, Robert Worth of Stevens Point, and Louis Wysocki of Custer.

K.B. Willett of Stevens Point was elected to the new position of lifetime emeritus director and Dr. George Anderson, also of Stevens Point, was elected member at large.

E. John Buzza of Stevens Point will continue as corporate counsel and James Radford of the university staff, as executive director of the foundation. ■

Theatre, dance get support from anonymous donor

An anonymous donor has established two funds within the theatre and dance department at UW-SP for emergency student loans and for purchases of equipment.

The contributor pledged to give \$1,000 annually, plus an extra \$500 donated in 1993 for a one-time special scholarship in the name of Alice Peet-Faust, longtime faculty member and department chair. The funds, given by a professional person who graduated from UW-SP in the late 1970s, are named in honor of professors James Moore of dance and Robert Baruch of theatre.

The emergency loan fund will bear Moore's name and will be available to theatre or dance students who have financial emergencies and are in need of low-interest loans. Students are expected to repay the money upon graduation.

The account honoring Baruch is set up for the purchase of needed equipment or supplies that the department's budget cannot cover. 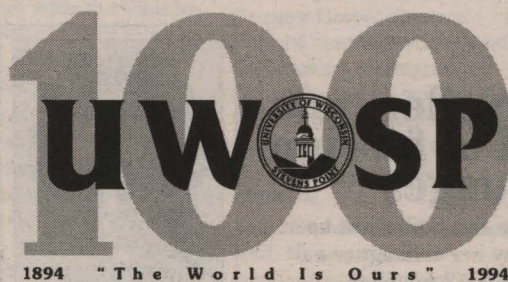
Women's group sponsors plaza

Gesell name lives on in institute here

In an autobiographical essay, Dr. Arnold Gesell described his alma mater, the Stevens Point Normal School ("established among the frontier pine stumps") as, "that far-away school, from which I graduated in 1899. It was a vivid, progressive institution and I owe much to it."

Ninety-five years later, the Gesell Institute for the Study of Early Childhood at UW-SP, which bears the name of this pioneer in the field of child development, exhibits those same qualities. It is a "vivid and progressive" program which impacts upon the lives of more than 100 university students, 70 children, and nearly 140 parents each semester.

Located within the School of Human Development and Nutritional Sciences, the institute is located on the first floor of the College of Professional Studies Building. Gesell's name was first used at the old campus laboratory school before it was closed and the early childhood program moved to its new facility about 15 years ago.

The institute originally was headed by the chair of the School of Home Economics; a full-time director was appointed in 1981. Janet Malone, author of the accompanying article about Arnold Gesell, served in the position for eight years, followed by James Gingles for two years and the current director, Mary Ellen Dallman, who is in her second year at UW-SP.

Dallman describes Gesell as, "a pioneer who dignified the importance of child study as a legitimate avenue of scientific investigation." She says he became well-known for introducing laboratories in which children could be studied and for identifying normal stages of development.

With its twice a week sessions for youngsters of various ages—infants, toddlers, preschoolers, and pre-kindergartners, the institute strives to create a "model environment." That environment strives to be "structured, safe and responsive" for its young clientele while providing a "focused and structured" experience for future teachers.

The program's six main goals are to provide children with opportunities for social interaction, to assure that they develop a positive self-concept, to assist them in the formation of positive attitudes toward learning, to offer a variety of activities and experiences, to provide opportunities to practice large and small motor skills and to encourage development of creativity.

Dallman believes an important element in building a model program is to attract a diverse student population. Currently the enrollment includes children from Paraguay, Chili, Poland, Korea, China, plus various religions, ethnic and economic backgrounds.

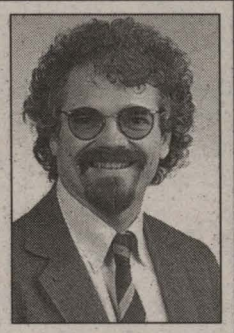
About 10 years ago, in order to serve a wider spectrum of children, the institute added an infant program for babies between three and 18 months of age and their parents. Dallman says her philosophy in studying the behavior of babies is to regard them as competent, inner-directed beings, to be responsive to them and to follow their lead as if the student teacher and the baby were partners in a dance. Formerly parents and child care workers were advised to continually stimulate babies, to try to cram as many activities as possible into their waking hours. These ideas have become outmoded in favor of more child-directed interactions, Dallman says.

The institute's student teachers also work with young special needs children who will eventually be included in local classrooms.

A committee made up of about 10 parents, three students and three staff members serves as advisor to the program. Many of today's participants are from a long line of Gesell families who continue to enroll each new generation and to be actively involved with each child's education.

During the 1990s, Dallman says the country's number one educational priority is for all children to be ready to learn when they enter school. UW-SP's early childhood institute named for one of the leading pioneers in the field, is doing its best to help fulfill that mission. ■

The board also named him as the first holder of the new Dorothy and Jacque D. Vallier Chair of Ecology in UW-SP's College of Natural Resources.

An ongoing gift from the Valliers, of Mequon and Tomahawk, to fund the chair and the distinguished professorship is the most significant in the university's Centennial Campaign, according to UW-SP Foundation Director James Radford. Boyce holds master's and Ph.D. degrees from Yale University, and joined UW-SP in September after serving since 1976 on the faculty at the University of Wyoming. A native of Iowa, he earned his bachelor of science degree from Iowa State University and his first master's degree from the University of Alaska.

In 1982-83, Boyce was a postdoctoral research fellow in animal ecology research at the University of Oxford in England. In 1991-92, he was visiting professor at the Centre for Theoretical Studies and Centre for Ecological Sciences at the Indian Institute of Sciences in Bangalore, India.

The "distinguished professor" has published four books and has authored or co-authored many papers for professional journals. He has served on the National Science Foundation and the NATO Postdoctoral Review Panels, is an assistant editor, consulting editor and member of the editorial board or on the editorial council of four scientific journals.

Jan Seiler new head of foreign languages

Professor Jan Seiler has been elected by her colleagues as chair of the 12-member Department of Foreign Languages at UW-SP.

Based on the vote, Justus Paul, dean of the College of Letters and Science, appointed her to a three-year term.

She and her husband, Mark, may be the only husband and wife who have both headed the same academic department in the history of the institution. Mark Seiler was chair about 15 years, beginning in the early 1970s.

A native of Texas, the new chair has a bachelor's degree from the University of Texas in Austin and a Ph.D. from the University of Wisconsin-Madison. She has been teaching German on campus since 1969.

Seiler and her husband have conducted many special summer institutes for foreign language teachers. ■

The Vallier Foundation's contribution follows many other gifts by Jacque and Dorothy Vallier to UW-SP, including the property that has been developed into UW-SP's Treehaven Field Station near Tomahawk. ■

Distance ed expert new administrator

An expert in the field of distance education assumed duties last fall as assistant vice chancellor for continuing education and extension at UW-SP.

Marvin J. Van Kekerix, director of academic telecommunications and professional development in University of Nebraska's Division of Continuing Studies, topped 143 other candidates for the position.

Vice Chancellor Howard Thoyre said Van Kekerix is nationally known for his expertise in delivering instructional offerings to off-campus sites through the use of technology. This approach to teaching will be pursued in Wisconsin with more emphasis in the next five years, according to Thoyre, and as a result, Van Kekerix' leadership will be especially important.

Prof records flood and Nixon gifts

A UW-SP professor is the author of a new book about how people in his native northeastern Pennsylvania seized opportunities to redevelop their cities at government expense after a devastating flood scourged the area two decades ago.

"Better Than Ever! The Flood Recovery Task Force and the 1972 Agnes Disaster" is a 167-page hardcover work by Robert Wolensky, a professor of sociology.

The book was published by the UW-SP Foundation Press at Palmer Publications in Amherst.

Wolensky wrote about the leadership, enterprise and initiative of the Flood Recovery Task Force, which "turned the flood into a blessing" in the large amount of federal aid it secured for the Wyoming Valley region.

"The disaster was an opportunity, and the people seized it," he added.

The climate for gaining generous assistance was right, because Richard Nixon was running for re-election as president and was concerned about whether he would carry Pennsylvania. Nixon's attitude about the requests for aid, according to Wolensky, was, "Give them whatever they want."

After the extent of the damage was known, Agnes was described as "The Greatest Natural Disaster in the History of the United States." Losses amounted to about \$3.5 billion, mostly in the region surrounding Wilkes-Barre, Pa. The relief included one percent loans from the federal government.

Never before or since has Uncle Sam given as much aid proportional to the damage. In addition, the aid became retroactive for several other disasters that had taken place across the country sometime earlier.

Wolensky reported that northeastern Pennsylvania was struggling from its past as a poor coal-producing area, and when the flood hit, the relief monies were used to remake the economy, image and political structure.

The elected government officials were overwhelmed by the responsibilities posed by the disaster and a de facto government emerged via the services of business people and community leaders on the Flood Recovery Task Force.

The task force, wanting a record of its work, awarded Wolensky a \$10,000 grant for the book project.

A native of the Wyoming Valley, Wolensky did his Ph.D. dissertation on Agnes at Pennsylvania State University and has since pursued the specialized study of disasters and their consequences. He has taught since 1976 in the Department of Sociology at UW-SP, where he also serves as co-director of the Center for the Small City. ■

Northern Illinois lauds Rick Wilke

Northern Illinois University has given its highest award for "lifetime contributions to outdoor and environmental education" to Rick Wilke, associate dean of the UW-SP College of Natural Resources.

Wilke was honored at De Kalb, Ill., last summer with the Lorado Taft Campus Award. He was presented with a plaque and invited to deliver a lecture on environmental education, which has been published in the university's "Journal of Outdoor Education."

Wilke is the 24th person to receive the award since 1970.

The first director of the Central Wisconsin Environmental Station near Amherst Junction in the mid-1970s, he is a professor of environmental education, and for the past several years has been associate dean of his college.

Wilke, who received his bachelor's and master's degrees from UW-SP, holds a doctorate from Southern Illinois University in Carbondale. ■

Norwegian government seeks opinion of Point professor

A professor at UW-SP has been pulled into an international controversy.

J. Baird Callicott, professor of philosophy, recently traveled to Oslo to advise members of the Norwegian government on the environmental and ethical implications of its decision to defy the international moratorium on whaling.

Callicott, who was on leave from UW-SP the fall semester, is a specialist in environmental ethics.

The Norwegian government has been under fire from many environmentalists around the world for its aggressive stance on whaling. ■

Jones does textbook workbook

Jane Jones, a health and wellness specialist on the UW-SP faculty, has published a workbook to accompany a nationally marketed textbook.

Jones, associate professor of health, physical education, recreation and athletics, is the author of "The Student Companion," printed and marketed by Benjamin/Cummings Publishing, Redwood City, Calif.

Jones was asked to write a supplement to the sixth edition of "An Invitation to Health," by Dianne Hales. The workbook provides assessment tools for each chapter of the text.

A licensed psychologist, Jones teaches courses in personal wellness, behavior change and healthy relationships. Some of her other topics are stress management, self-hypnosis, loss and grief, and healthy helping. She holds a Ph.D. from the University of Chicago. ■

Music educators honor McKenna

The Wisconsin Music Educators Association gave its highest recognition of 1993 to Gerard McKenna, dean of the College of Fine Arts and Communication at UW-SP.

The association's Distinguished Service Award was presented to McKenna during a banquet at the Holiday Inn-West in Madison.

Annual recipients are chosen for their "significant contributions to music and music education over a sustained period of time."

The association has 1,500 members.

McKenna has been the dean of fine arts and communication at UW-SP since 1989, and came here after serving 15 years at UW-Milwaukee. He was chair of the music department in Milwaukee eight years and served a stint as acting dean of the School of Fine Arts there. He is a native of Brooklyn who holds a Ph.D. in music education from the University of Nebraska. ■

Bill Kirby wins praise for distance learning work

A UW-SP professor's use of a computer in his statistics lectures is being acclaimed as an example of how learning capability can be enhanced by a variety of presentation sources.

Representatives from the Center for Information and Communication Sciences at Ball State University in Indiana have identified William Kirby's course at UW-SP as containing among the best practices in the nation in distance learning.

Kirby's work was acknowledged in a paper by the Ball State researchers, which was presented at a conference on educational technology in Orlando, Fla. last fall.

The statistics course taught by Kirby has appeared every semester on Wisconsin Public Television since the spring of 1990. In addition, he has lectured for the first course UW-SP has offered via satellite to a 23-state region. He also has taught several courses for teachers on a microwave system from the Professional Studies Building to locations in several north central Wisconsin cities. ■

Behm book, which 'sold in thousands,' now bilingual

A small softcover book promoting literacy, written by a UW-SP professor and his wife, has gone into a second edition as a bilingual publication after being a big seller in English.

"Let's Read—101 Ideas to Help Your Child Learn to Read and Write" is the work of Richard and Mary Behm, and has received rave reviews from readers since coming off the presses three years ago, according to the publisher.

The bilingual version is in Spanish and English.

The English edition sold "by the tens of thousands," according to Warren Lewis, director of publications for the federally funded Education Research Information Center in Bloomington, Ind., which prints and markets the 49-page book.

Behm, a professor of English, has served at UW-SP since 1976. His wife, Mary, is an English teacher at the Stevens Point alternative high school. ■

Dean on Preservation Council

Alan W. Haney of the UW-SP faculty has been appointed to a three-year term on the state's Natural Areas Preservation Council.

Created by the Legislature, the 11-member council recommends policies for acquiring, designating, managing and keeping an inventory of scientific areas.

Haney, who is dean of the College of Natural Resources, is one of four representatives from the UW System on the body. His appointment was made by the Board of Regents. Haney has a doctor of philosophy degree from the New York State University College of Environmental Science and Forestry. ■

Arnold L. Gesell: 'Big man on Campus'

This story of a distinguished graduate of UW-SP is from a larger article about Gesell by Janet Malone of the School of Human Development and Nutritional Sciences.

On October 10, 1896, Stevens Point Normal School student Arnold Gesell wrote this in a letter to his parents: "What comes next may surprise you, but my money is nearly all used. My board is paid a week ahead, and I have about \$2.50 to my credit, but would like some more, so please send it right away. I know it costs money—but you'll see whether it's well invested." That this money was well invested is evident upon reflection, nearly 100 years later, upon the distinguished career of Dr. Arnold Gesell. On May 3, 1969, the Wisconsin State University at Stevens Point celebrated its Diamond Jubilee. At the time of this celebration, Gesell was recalled as "one of the most distinguished scholars" ever to study at the institution.

This member of the class of 1899 of the Stevens Point Normal School went on to pursue a career which elevated the study of child development from the speculative to the scientific. In the course of his career, Dr. Gesell authored or co-authored some 30 books, founded the Yale Institute of Child Development, and after his retirement from Yale, continued his work in the founding of the Gesell Institute of Child Development in New Haven, Connecticut. Not only did his work make significant contributions to the scientific study of children, but also provided valuable practical information to parents and teachers in the guidance and education of young children.

In his autobiography, Gesell described Stevens Point Normal School as a "vital progressive institution" to which he owed much. He talked about his memories of this institution in a letter written in 1932 to one of his former teachers, Mary D. Bradford:

"My memories of the Stevens Point Normal School are of the golden age sort. They are perhaps tinted by the colors which glow when a boy is in mid teens; but my reflective judgment confirms my juvenile impressions that the Stevens Point Normal of the gay nineties was an important seat of learning. The Normal School itself had architectural charm and modernity though set in an almost primitive pine land. And it had modernity of spirit. The "new-fangled" card catalogue of the library, the laboratory courses, the imported football coaches, the imported lectures (with wonderful lantern slides!) from foreign parts, the inter-school contests, the fresh vigor of the faculty and its young president, all bespoke progressiveness."

A native of Alma along the Mississippi River, Gesell was a serious-minded child. While still a teenager, he participated in the teachers' institutes that were held in Alma during the summer months. During one of these institutes, he was befriended by C.H. Sylvester, who was the state institute conductor. Mr. Sylvester, according to Gesell, "must have been amused at my presence and my young seriousness." The institute conductor gave Gesell a pocket microscope and took him on a nature study trip to the top of the bluffs.

Mr. Sylvester was one of the original faculty of the Stevens Point Normal School and was the reason that Arnold Gesell chose to attend this "far away school." Mr. Sylvester was mentor to the young Gesell. In the commencement address which Gesell presented on the fortieth anniversary of the founding of Central State Teachers College on June 9, 1934, he described Mr. Sylvester as "almost a co-founder of the school" and wrote, "My own debt to him is beyond repay, for he gathered me to this school."

Gesell began the academic preparation for his distinguished career when, at age 16, he left home and moved into a boarding place on Church Street in Stevens Point. On August 25, 1896, he wrote his family telling them of his safe arrival in Stevens Point. He added, "But another and bigger reason for writing now is because I feel as if I wanted to see you very bad, in other words, because I am a little homesick." He said the boarding place was "about as good as any there is to be found." It was a \$3.50 place but since two would room together they would only be charged \$3.00 apiece. He wrote that the Normal Building was "fine" as was the gymnasium.

Four days later, he wrote that he thought he would like Stevens Point, but he wasn't used to things yet. Gesell was pleased on the day that he wrote this letter because he had finally gotten a chance to see the president and he now knew what studies he would be taking—drawing, theory of teaching, composition, geometry, and vocal music. He also described his schedule in this letter. Recitations, so he wrote, lasted about 3/4 hour each. At 8:45, there were morning exercises and at 10:20 there was a ten-minute recess. At 3:45, they were going to have Physical Culture. Most of the students carried four studies, but he was going to try five.

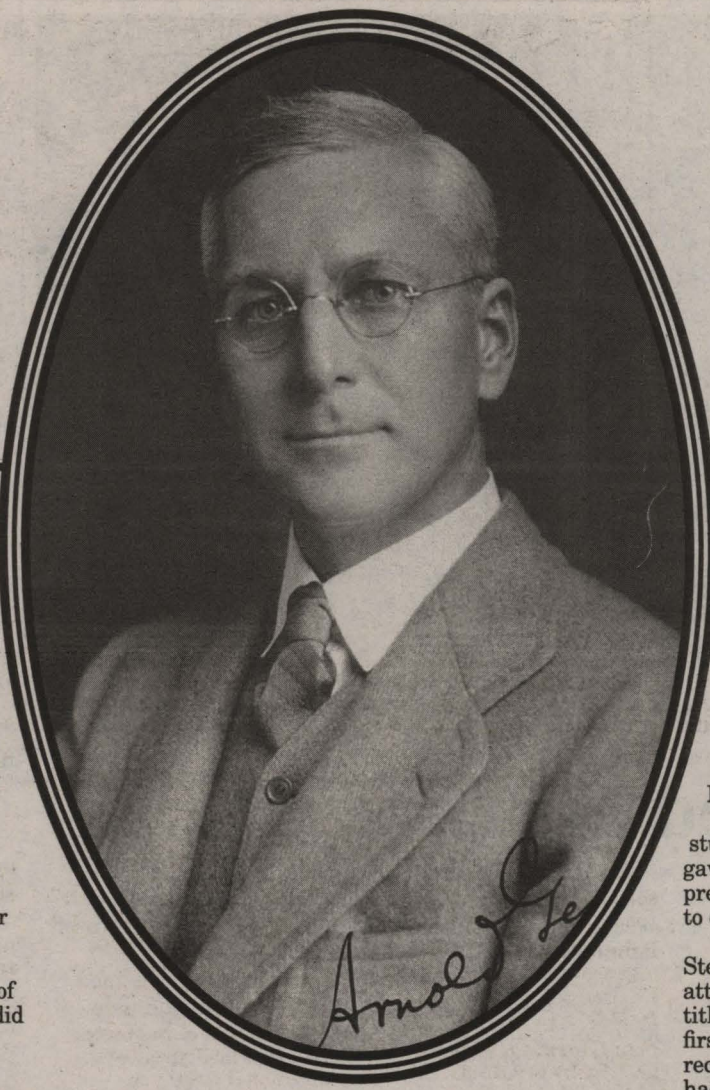
In his letter, he described the town of Stevens Point for his family:

"I see you don't know what kind of a city Stevens Point is. Well, it's about four times as large as Alma. It lies on the Wisconsin River, but that isn't anything like the Mississippi. There are several bridges across the river. Stevens Point is level. No Alma bluffs around. I miss them. It is sandy, but quite a number of people manage to keep green lawns. The Normal grounds are neat and clean."

In typical student fashion, Gesell talked to his family about his studies and the teachers. He wrote:

"Our drawing teacher at the Normal is kind of a queer one, not exactly queer, but not very well liked. I like 'drawing,' but it almost takes too much time. . . The teacher says my work is very good. She put up one of my drawings for the others to look at and take as an example. My but ain't I a bragger?"

Another of his studies was composition. Gesell thought the composition teacher was "fine" though her method was



not to mark high. One of his compositions was titled, "The Value of the Bicycle." In this composition, he wrote:

"The bicycle, I think, should be classed among the great inventions of the nineteenth century. Its great popularity proves its value. . . the bicycle is much used by teachers, professors, students, business men, and others in like situations. . . Besides being a thing of amusement and exercise, it is a saver of energy. It is less work to ride a bicycle than it is to walk. People who leave their work tired and worn out find it of good use in going home."

The 'low-marking composition teacher' gave him an 81 on this essay and wrote, "Subject is too impersonal. Try to put your own individuality into your work." Student Gesell also wrote about his Physical Culture class. He said that the classes were now organized and met every Wednesday and Friday to exercise a half-hour in the gymnasium. "The teacher," wrote Gesell, "is a lady. She wears bloomers."

In his second year at Stevens Point Normal School, Arnold Gesell took a course in psychology with Professor Edgar James Swift as instructor. In the 1934 commencement address, Gesell described Professor Swift as "an able, independent-minded representative of the new science of educational psychology. He conducted his work on a collegiate and sometimes even on a university level, introducing individual research projects." Professor Swift had been trained at Clark University and had studied under G. Stanley Hall. Gesell gives Swift the credit for directing him to Clark University and to his association with Hall. This was later to be a crucial relationship in deciding the direction which Gesell's work was to take.

But Gesell wrote, "Despite the excellent instruction and class work at the Stevens Point Normal, I recall most vividly my extra-curricular activity." On October 17, 1898, he wrote a letter to his family in which he described these extra-curricular activities. He wrote:

"Actually, I have rarely been as busy, that is had as much to do, as this year. There is plenty of studying to be done on the studies; and I have just finished an oratorical essay on witchcraft which has taken a great deal of time; and being treasurer of the Athletic Association I have quite a little collecting, etc. to do, and captain of the football team meant business, but I have given up football so I have a little more time. . . But what has been taking so much of my time is as you will guess now, The Pointer."

Arnold Gesell began his association with the NORMAL POINTER as the local reporter. His column included accounts of who was sick, who was visiting in Stevens Point and who had been out of town.

After a stint as local reporter, Arnold Gesell was elected to be editor-in-chief. He wrote to tell his family about this achievement:

"The Pointer comes out tomorrow and I am very anxious to see how the faculty and students will judge. At first I thought I wouldn't want the position, but I'm glad I took it now; and I didn't have to canvass either. It really means quite a little for a fellow's reputation. The day before the election at morning exercises, the president gave a talk on the Pointer in which he said that the position of editor-in-chief was the highest the school could offer."

In the second issue of his editorship, Gesell's editorial espoused the cause of woman suffrage and praised the Stevens Point Normal School for advancing the cause. He wrote:

"The cause of woman suffrage has made another great advance in our school. At a meeting of the Athletic Association the women of the school were, by an amendment to the constitution, given the power to become active members of that important organization. There has been a tendency to consider that boys are for athletics, and athletics are for boys. But the girls play tennis, and last winter they had a basketball team which is to be reorganized. . . Now the girls are on equal footing with the boys in athletics."

Student Gesell was also involved in athletics—both as a participant and a spectator—while at Stevens Point Normal. One of his athletic interests was track. He wrote to his family that he had won the mile run so that meant he was on the track team and would go to Oshkosh for a field day—all expenses paid. Later, Superior was to come to Stevens Point for a field day.

Arnold Gesell

Being a member of the track team required training and dieting. He wrote to the home folks about the training table. He said, "Our training table is still going. You ask what the bill of fare is. Well, I'll try and give you some idea." Following is Gesell's description of a typical day's menus on the training table: breakfast—crystal wheat or graham mush or oatmeal, sauce or fresh fruit, graham bread, panmalt; dinner—beef steak or other meat, potatoes, vegetable (cooked), sauce; supper—eggs (poached), graham bread, sauce, panmalt.

Gesell added, "We have nothing whatever that is fried. Nothing to drink until the meal is over. No pastry. No salt and pepper. And I'm feeling better already."

Football was also of interest to the Normal School student. He was captain of the second string team, but he gave that up in order to have more time to spend in preparation for the oratorical contest which he had decided to enter. But he continued to avidly support the team.

Arnold Gesell's true claim to fame while a student at Stevens Point Normal School was as an orator. His first attempt at oratorical fame was a paper which he wrote titled, "John Brown: The Man." Though unsuccessful in this first effort, he tried again. In his autobiography, Gesell recalled that in his junior year, his mentor, Mr. Sylvester, had given him a copy of the book, "History of the Rise and Influence of the Spirit of Rationalism in Europe," by W.E.H. Lecky. He further recalled that though he was too immature to completely digest this work, "it made a deep and lasting impression, by virtue of its exalted, eloquent diction and its noble aura of liberal humanitarianism." This book was the inspiration for his second attempt as an orator. His speech titled, "The Development of the Spirit of Truth," carried out themes of "intolerance, persecution, and freedom of thought" and won for Arnold Gesell first place in local, intrastate, and interstate contests.

Winning the intrastate contest began with a local contest where six students competed for the honor of representing Stevens Point in the state contest. The Pointer account of this activity said:

"Up until the close of the fifth oration, the decision was still doubtful, but from the time the first sentence of the now familiar oration passed the orator's lips, all doubt was gone. . . And when that magnificent conclusion came ringing to our ears. . . there was not one who heard it but that knew that the state contest was his."

Next came the interstate contest. Orations presented showed the optimism and idealism of youth at the close of the nineteenth century. The Milwaukee representative said, "As an epoch in human progress, this century towers above its predecessors like the snowcapped mountains above the willowed plain." The Whitewater orator spoke, "In this land unembarrassed by obsolete customs and unfettered by decayed institutions, opportunity is a watchword. Yea, America is but another word for opportunity." In his oration, Gesell declared:

"But if the past has been dark with despair, the future is bright with hope—the brighter era is fast coming when man will develop not by physical struggle, but by appeals to reason and to justice—not by catastrophe but by peaceful evolution."

Gesell emerged as the winner of the contest. However, according to the Pointer account, "for a time it looked doubtful." The author explained the reason for doubt as:

"Whitewater was here, glorifying in the prestige of two victories already won. Oshkosh was here two hundred strong, with their "Just One Girl" who talked for Grant. Finally, and the most feared of all, was McMahon of Milwaukee whose "Abraham Lincoln" had brought him an easy first in the home contest."

Arnold Gesell died in 1961 at his home in New Haven, Connecticut. At the end of his life, he returned to his Wisconsin roots as he requested that his "final resting place be in the Alma Cemetery beside his parents and others in the family. He was granted his wish when the urn containing his ashes was interred on the family lot." His grave, high on a bluff overlooking his beloved Mississippi River, is marked with a native boulder inscribed simply with:

Arnold L. Gesell, M.D.
1880-1961

The ties between UW-SP and Arnold Gesell live on nearly one century after the graduation of the BIG MAN ON CAMPUS from the Stevens Point Normal School. In 1971, permission was requested of the Gesell family to use the name in renaming the Campus Laboratory School (then housed in what is now the Communication Arts Center). Permission was given and at a rededication ceremony on December 3, 1971, the school was renamed The Gesell Institute for the Study of Early Childhood. With the new name came a new mission which more closely reflected the goals of Arnold Gesell's profession. This new mission, according to Campus School Director Dr. John Pearson, would be the development of new programs in early childhood education and learning disabilities.

At the rededication ceremony, a portrait of the famed alumnus was unveiled.

On June 5, 1988, Arnold Gesell was posthumously given the University of Wisconsin-Stevens Point's "Distinguished Alumnus Award." This award is the highest recognition that UW-SP gives to its graduates. The name of the BIG MAN ON CAMPUS at Stevens Point Normal School has become one of the biggest in the world in the study of young children. The ties to UW-SP live on in the program that bears his name. ■

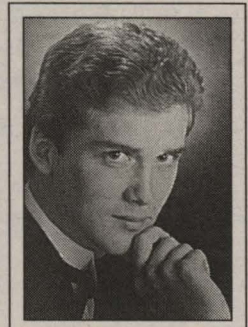

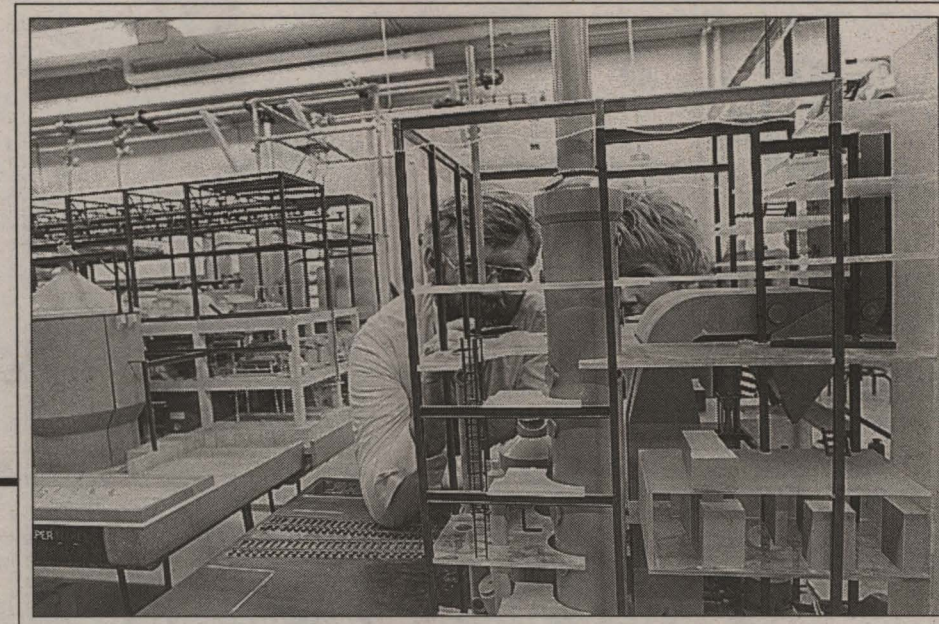

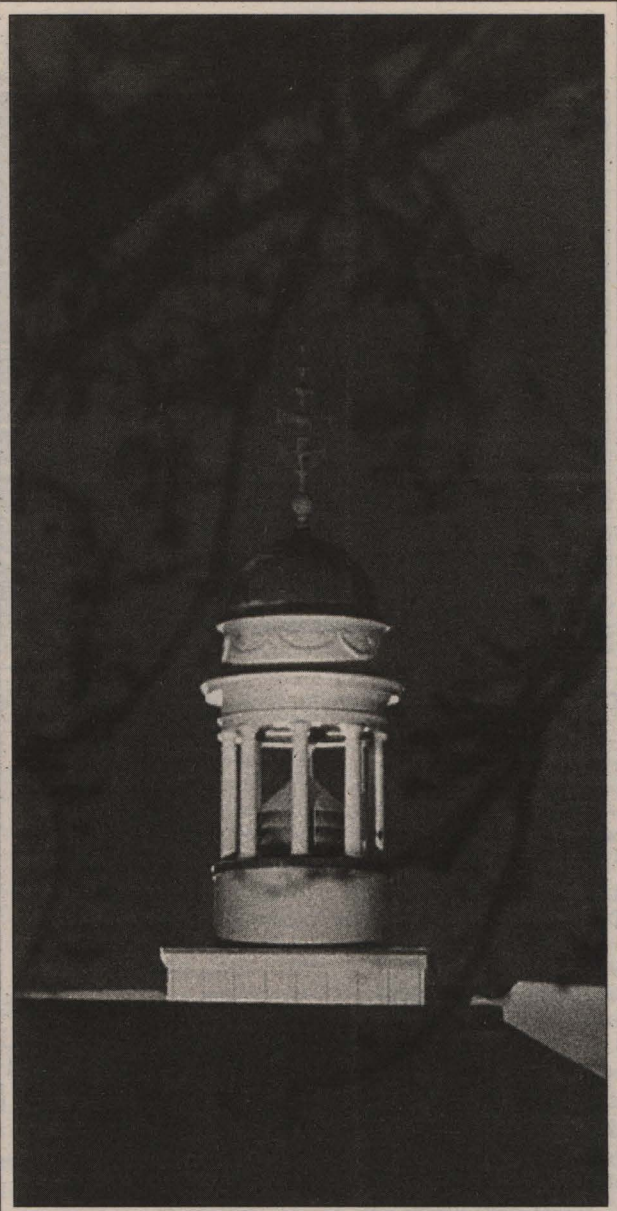

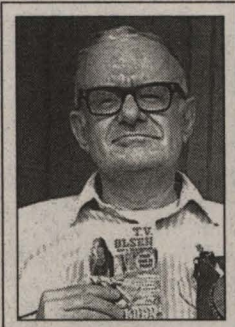


The cast of 1776 won top regional honors in recent competition, under the direction of Arthur Hopper.

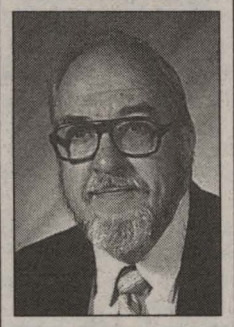

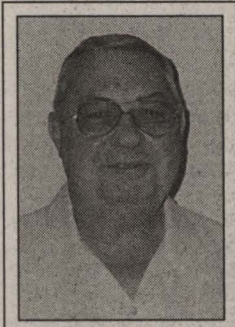

Survivors include one daughter, one son, two sisters, ten grandchildren and ten great-grandchildren.

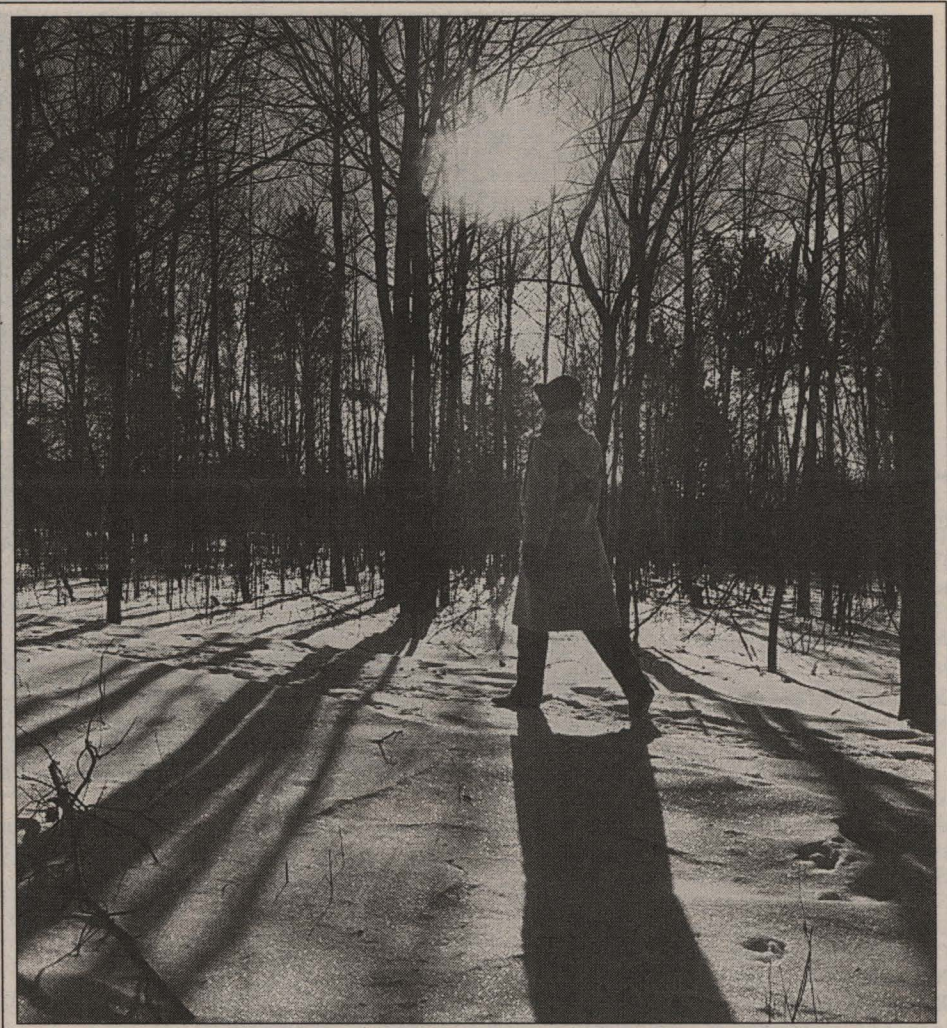
